Offals of buffalo too are subject to the same conditions of quality control and inspection. Laboratories duly recognized by APEDA , as well as in- house laboratories attached under the abattoirs cum meat processing plant registered with APEDA and Agency approved labs, may also be used to conduct the necessary tests for confirmation of quality under the supervision of the designated veterinary authority of the State. On the basis of these test and inspections carried out by Veterinarians, duly registered under the Indian Veterinary Council Act, 1984, employed by the exporting unit and supervised by the designated veterinary authority of the state, the veterinary Health Certificate may be issued by the designated authorities of the state.

3	Exports of gonads and other reproductive organs of buffaloes and the germplasm of cattle and buffaloes in heading 0511 require a Restricted Export authorisation.		
4	Export of meat and meat products will be allowed subject to the exporter furnishing a declaration, attached with copies of valid APEDA Plant Registration Certificate(s) to the customs at the time of export that the above items have been obtained / sourced from an APEDA registered integrated abattoir or from APEDA registered meat processing plant which sources raw materials		

	exclusively from APEDA registered integrated abattoir/abattoir.		
5	On the cartons for export of meat, the following details shall compulsorily be mentioned:- (i) Name of the Product. (ii) Country of Origin (iii) APEDA Plant Registration No. (iv) Name of the exporter.		
6	The designated veterinary authority of the State where meat processing unit is located, may issue the certificate on the basis of the inspections carried out by Veterinarians duly registered under the Indian Veterinary Council Act 1984 employed by the exporting unit and supervised by the designated veterinary authority of the State. The Inspection Fee prescribed under the Export of Raw Meat (Chilled/Frozen) (Quality control and Inspection) Rules, 1992 shall continue to be paid by the exporting unit to the Agency as currently applicable.		
7	Exports of All wild animals, animal articles including their products and derivatives excluding those for which ownership certificates have been granted and also those required for transactions for education, scientific research and management under Wild Life (Protection) Act, 1972 including their parts and products are Prohibited and not permitted to be exported.		
8	i. Specified Meat and meat products shall be allowed to be exported as Halal certified to the countries listed below, only if such products are produced or processed and/or packaged in a facility certified under the 'India Conformity Assessment Scheme(I-CAS)- Halal' of the Quality Council of India (QCI). ii. After the shipment(s) are made, the exporter shall provide valid Halal Certificate(s) issued under I-CAS by a Certification Body accredited by the National Accreditation Board for Certification Bodies (NABCB) to the buyer in the importing country listed below. iii. In addition to the requisite conformity with I-CAS, the export of specified meat and meat products to countries wherein regulation(s) for import of Halal products are notified, the producer/supplier/exporter shall also meet the importing country's requirements and regulations, as applicable, and shall provide valid certificate(s) to the buyer in the importing country issued by Halal Certification Bodies approved under the National Halal system of the Importing Country. iv. The Policy Conditions and Procedures thereof for the Export of Non-Halal Certified Meat and Meat products remain unchanged. v.
