Notes to Section A

1. Chapter 15 (Government Procurement) only covers those central government entities listed in this Section and any subordinate entity of those central government entities conducting procurement in an independent manner.¹ Each of such subordinate entities shall be treated as a separate procuring entity for the purposes of Chapter 15 (Government Procurement) and this Section.
2. All central public sector enterprises (“CPSEs”) established or maintained by the central government entities listed in this Section are covered,² except any CPSE exposed to competitive market forces in any of its operations. The determination of exposure to competitive market forces shall be based on the following factors:
 - (a) there is an actual or potential presence of one or more persons providing similar or equivalent goods or services in the market the CPSE operates in;
 - (b) the price of goods or services offered by the CPSE is determined on a market basis; or
 - (c) there is no restriction on access to the market the CPSE operates in under any laws, rules or regulations.

Section D

Goods

Unless otherwise specified in this Agreement, Chapter 15 (Government Procurement) covers procurement of all goods by the entities listed in Section A (Central Government Entities).

Section E
Services, other than Construction Services

Unless otherwise specified in this Agreement, Chapter 15 (Government Procurement) covers procurement of all services by the entities listed in Section A (Central Government Entities).

Section F
Construction Services

Unless otherwise specified in this Agreement, Chapter 15 (Government Procurement) covers procurement of all construction services by the entities listed in Section A (Central Government Entities).

Section G

General Notes

1. Chapter 15 (Government Procurement) shall not apply to:
 - (a) procurements for the protection of essential security interests including the procurement of arms, ammunition or war materials, or procurements indispensable for national security or for national defence purposes;
 - (b) preferences provided under the *Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012*, as amended from time to time;
 - (c) procurements of agricultural products made in furtherance of agricultural support programmes and human feeding programmes (e.g. food aid including urgent relief aid);
 - (d) procurements of goods or services for the establishment and operation of any overseas mission or subordinate or attached office or autonomous or other entity of any nature outside the territory of India;
 - (e) procurements by a procuring entity from another government entity;
 - (f) procurements of goods or services outside the territory of India for consumption outside the territory of India; or
 - (g) procurements by any entity not covered by Chapter 15 Government Procurement or Section A (Central Government Entities).

Section H
Applicable Threshold Adjustment Formula

1. India shall calculate and publish the value of the thresholds under Chapter 15 (Government Procurement) expressed in Indian Rupee after the Parties have exchanged written notifications confirming that they have completed their respective domestic legal requirements, necessary for entry into force of this Agreement and before the date of entry into force of this Agreement.
2. India shall notify the United Kingdom, not later than two years from the date of previous notification, of the then current thresholds in its currency and the method of calculating such thresholds. India shall calculate and convert the value of the threshold under Chapter 15 (Government Procurement) expressed in Indian Rupee.
3. These calculations shall be based on the conversion rates published by the International Monetary Fund.
4. India shall consult if a major change in its national currency relative to the SDR or to the national currency of India were to create a significant problem with regard to the application of Chapter 15 (Government Procurement).
