(a) & (b): Yes, Sir. The Agricultural and Processed Food Products Export Development Authority (APEDA) has made special efforts to promote exports of agriculture products from the North-Eastern Region (NER). APEDA provides assistance to exporters under various components of its export assistance scheme viz. Development of Export Infrastructure, Quality Development and Market Development. The exporters from NER are entitled to higher levels of assistance i.e. up to 75% (compared to 50% for exporters from other regions) for various activities/ sub-components under the scheme. APEDA has also organized several sensitization meetings/ programs in the NER, in association with State Departments, State Agriculture Universities and Krishi Vikash Kendras for identification of progressive farmers' groups and strengthening the export linkage for Farmer-Producer Organisations (FPOs)/ Farmer Producer Companies (FPCs). A number of International Buyer-Seller Meets have also been organized for the exporters of NER.

(d) to (f) : The Government has not received any specific complaint regarding traders making huge profit out of exports, without paying remunerative prices to the farmers for their produce. However, the Government has taken steps to provide direct export market linkage to farmers/ Farmer-producer organisations (FPOs). A Farmer Connect Portal has been set up for providing a platform for farmers, FPOs and cooperatives to directly interact with exporters. Capacity building programmes, BSMs, workshops etc. have also been organized to directly involve FPOs in exports.

(a) : The major initiatives taken by the government for export growth from Assam are as below:

(1) Steps taken by Agricultural & Processed Food Products Export Development Authority **(APEDA)** :

- i. Organizing International Buyer-Seller Meet (BSM) in North East to boost export for the region.
- ii. Providing financial assistance through Financial Assistance Scheme (FAS) to facilitate the exporters of Agri - products by providing assistance to exporters under the following components (i) Development of Export Infrastructure, (ii) Quality development and Market Development
- iii. Organizing several sensitization meeting / programs in NER in association with State Departments, State Agriculture Universities, Krishi Vikash Kendra, Farmers for identification of progressive Farmers groups and strengthening the export linkage of FPOs/FPCs.

iv. Export oriented production clusters have been identified and notified in various districts under Agri Export policy.

(2) Intensive Buyer-Seller Meet (BSM) for the tea importers from Russian Federation, UAE & the GCC countries were organized on virtual platforms during Sep-Oct 2020 in collaboration with the Indian Missions in Moscow and Dubai respectively, where a couple of exporters from the NER participated for promotion of “Assam Orthodox Teas” and “Assam CTC Teas”. Furthermore, Financial assistance to stakeholders for export of tea through the ICD Amingaon is provided under the Tea Development & Promotion Scheme.

(3) The initiatives taken by **Spices board** include Implementing various schemes for post-harvest improvement and export promotion of spices, benefiting stakeholders of the Spices Sector in Assam. Under the Integrated Scheme for Export Promotion & Quality Improvement in Spices and Research & Development of Cardamom- from FY 2021-22, various programmes have been implemented by the Spices Board, in the State of Assam:

- i. Organized Quality Improvement training programs (QITP) benefitting 500 beneficiaries of Assam to provide training on quality and safety aspects of spices in line with the applicable standards of various importing countries, so as to facilitate generation of an exportable surplus.
- ii. Provides a platform for interaction and building direct market linkages between spice growers, exporters and importers, by organizing Buyer Seller Meet(BSM) meets across India. During FY 2022-23, an International Buyer Seller Meet(IBSM) and Spices Conclave was held at Guwahati, Assam.

(4) Under Trade Infrastructure for Export Scheme (TIES), the Central Government assistance for infrastructure creation is in the form of grant-in-aid. For the projects located in North Eastern States this grant can be upto 80% of the total equity.

(b) to (d) : The funds spent by Tea Board, Spices Board, APEDA and TIES is at Annexure. The overall exports from Assam during the three years is as below :-

(a) : India Trade Promotion Organisation (ITPO) organizes the participation of Indian companies in overseas exhibitions to explore the potential of their products in overseas markets. ITPO also organizes domestic trade fairs both Business to Business (B2B) and Business to Consumer (B2C) to provide a common platform to Indian companies all over the country for brand launch, promotion, positioning and new business tie-ups as well as retail sales. These exhibitions include the multiproduct flagship India International Trade

Fair (IITF) Delhi, AAHAR the International Food and Hospitality Fair Delhi, India International Leather Fair (IILF) Chennai, India International Footwear Fair (IIFF) New Delhi, India International Security Expo (IISE) Delhi, Delhi Book/ Stationary Fair, New Delhi and Nakshatra Fair. ITPO undertakes comprehensive publicity of International and domestic trade fairs through print, electronic and social media.

(a) & (b): The details of value of export of wheat during last three years and current year is as follows:

The data in the above table reveals that export of wheat has increased since 2019-20. The reasons for the increase include various factors like international demand-supply situation, rise in global commodity prices, higher domestic supply of wheat, conflict between major wheat exporting nations like Ukraine and Russia, etc.

(c) & (d): The Government vide notifications No: 06/2015-2022 dated 13-5-2022 have prohibited export of wheat except in cases where Letters of Credit (LCs) message exchange in SWIFT has happened on or before 13.05.2022 or on the basis of request of vulnerable and neighboring countries facing a food security situation. The continuation of wheat export is dependent on domestic supply situation and international demand-supply conditions.

- (a) whether the Government has allocated 1000 crore rupees in the Union Budget 2021-22 for the welfare of tea garden workers of West Bengal and Assam;
- (b) if so, the details funds spent, works done and beneficiaries so far, State-wise;
- (c) the details of implementing agencies for the above funds in both the States;
- (d) the details of wages of tea garden labour as in different States including West Bengal; and
- (e) the other steps being taken by the Government for the welfare of tea garden workers?

(a) to (c): A provision of Rs. 200.00 crore was made available in Budget of Tea Board during the year 2021-22 for a scheme to be formulated for the welfare of tea workers in the States of Assam and West Bengal. The Government is in process of finalizing the details of various works to be taken up under this scheme. These works will relate to sectors such as health, education, skill development, infrastructure for provisioning of welfare services to tea workers especially women and their children. The scheme guidelines are likely to be finalized soon.

(d): The details of wages of tea garden workers in different States including West Bengal is given in Annexure.

(e): The working conditions and the welfare measures for workers working in the tea gardens in the country are governed by the Plantation Labour Act, 1951 (PLA). The Act requires the employers to provide the workers, including women, with housing, medical facilities, sickness &

maternity benefits and other forms of social security measures. There are provisions for educational facility for the children, drinking water, conservancy, canteens, crèches and recreational facilities for the benefit of the plantation workers including tea and coffee workers and their families in and around the work places in the tea and coffee plantations.

Besides PLA, number of other industrial and social security legislations such as Workmen's Compensation Act, 1923, Payment of Gratuity Act, 1972, The Employee's Provident Funds & Miscellaneous Provisions Act, 1952 (Assam Tea Plantation Provident Fund, Pension Fund and Deposit Linked Insurance Fund Scheme Act 1955 – only for Assam), Payment of Bonus Act, 1965, Maternity Benefit Act 1961, Payment of Wages Act 1936 etc. provide various benefits like gratuity, bonus, provident fund, equal remuneration etc. to tea and coffee plantation workers. The provisions of these Acts have now been subsumed in four labour codes-the Occupational Safety, Health and Working Conditions Code, 2020, Social Security Code, 2020, Code on Industrial Relations, 2020 and Code on Wages 2020.

Tea Board has also implemented certain welfare activities under Human Resource Development (HRD) component of the "Tea Development and Promotion Scheme" during the Medium Term Framework(MTF) period from 2017-18 to 2019-20 and extended till 2020-21, aimed at improving the health and hygiene of workers, education of wards of workers and imparting training to improve skills for growers/workers. Financial assistance of Rs. 18.11 Cr. was extended under HRD component during MTF period.

The "Tea Development & Promotion Scheme" approved for implementation by Tea Board during the 15th Finance Commission period from 2021-22 to 2025-26 also has a component for the welfare of small Tea growers and their workers.

- (a): Yes. India and the United Arab Emirates (UAE) signed the Comprehensive Economic Partnership Agreement (CEPA) on 18th February, 2022, on the side-lines of the India-UAE Virtual Summit, to boost trade between the two countries. The India-UAE CEPA entered into force on 01 May 2022.
- (b): The India-UAE CEPA is a comprehensive agreement, which covers, *inter-alia*, Trade in Goods, Rules of Origin, Trade in Services, Technical Barriers to Trade (TBT), Sanitary and Phytosanitary (SPS) measures, Dispute Settlement, Movement of Natural Persons, Telecom, Customs Procedures, Pharmaceutical products, Government Procurement, Intellectual Property, Investment and Trade, Digital Trade and Cooperation in other Areas.

The CEPA between India and the UAE covers almost all the 8-digit Harmonized System (HS) tariff lines of India (11,908) and the UAE (7,581) respectively. India will benefit from preferential market access provided by the UAE on over 97 % of its tariff lines which account for 99% of Indian exports to the UAE in value terms.

Labour-intensive sectors such as Gems and Jewellery, Textiles, leather, footwear, sports goods, plastics, furniture, agricultural and wood products, engineering products, medical devices, and Automobiles are expected to be among the top gainers for India. Tariff concessions offered to the UAE by India, especially on raw materials and intermediate products such as crude petroleum, certain petrochemicals, and Gold, will in turn reduce the input costs for the downstream labour-intensive industries like Gems & Jewellery and Plastics, and provide a boost to domestic manufacturing of these downstream products.

The list of the goods on which anti-dumping duties have been imposed in the last three years is Annexure -I. However, there is no existing anti-dumping duty on the imports of pulses and food grains. The Government has recently increased import duty on Oil, Shell Cakes, Shell Moulds, Hand Devices etc., the details of which are Annexure -II.

(a) to (d): In exercise of the powers conferred by sub-section (3) of section 4 of the Rubber Act, 1947 (24 of 1947) read with rules 3 and 4 of the Rubber Rules, 1955, the Government has reconstituted the Rubber Board vide extraordinary Gazette notification No. S.O. 2980 (E) dated 28.06.2022. The details regarding members of the Rubber Board is attached as Annexure.

(e) to (g): There have been widespread changes in the overall market scenario with reference to the development of Rubber and allied sector in the country. Therefore, to remove certain archaic provisions to create a conducive environment for ease of doing business and for making a world class Rubber Industry, the Government considers it expedient to repeal the existing Rubber Act 1947 and enact a new legislation. In this regard, a draft Bill 'Rubber (Promotion and Development) Bill 2022' was hosted in the official website of this Department and Rubber Board for wider consultation and seeking comments/ suggestions from public/ stakeholders. 522 stakeholders and public have submitted their objections/suggestions on the draft 'Rubber (Promotion and Development) Bill 2022'. Last date to receive the objections/suggestions was 9th April 2022. Recommendations/suggestions have been received regarding definitions, objectives, constitution of the Board, functions, provision relating to minimum and maximum price for rubber, declaration of Minimum Support Price, provisions for declaring status of rubber as agriculture produce, request not to repeal the Rubber Act 1947, etc.
