- (a) the value and volume of exports and imports taking place from India's ports (all individual ports), category-wise (ICD, CFS, LCS, Sea Port, AFS etc.) and during the last ten financial years and current year, State and district-wise; and
- (b) the details of the promoters of the ports and categorize it as public, private or other categories so far?

Exported/Imported volume/quantity of different items is in different units, hence is not additive.

The state-wise merchandise export during last 10 years and current year are at **Annexure I**.

The district-wise merchandise export is available 2021-22 onwards and is at **Annexure II**.

(b) The 12 Major Ports in India namely Deendayal, Mumbai, J.L.Nehru, Mormugao, New Mangalore, Cochin, V.O. Chidambaranar, Chennai, Kmarajar, Vishakhapatnam, Paradip and SMP (Kolkata/ Haldia), are under the administrative control of Ministry of Ports, Shipping and Waterways, Government of India. At Major Ports, the projects/berths/terminals are allocated on the basis of open Competitive bidding under Public Private Partnership (PPP) mode to private players for a limited period on revenue/royalty sharing basis.

Establishment & administrative control of Non-Major Ports are within the purview of respective State Governments. They allocate ports to private players for operation / management on concessionaire agreement for fixed period.

The list of cargo handling Non Major Ports along with their status, mode of operation and concessionaire is at **Annexure III**.
