Will the Minister of **COMMERCE & INDUSTRY** (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- a) the quantum and value of medicines/drugs exported and imported during each of the last three years and the current year, country-wise;
- b) whether India is largely dependent on import particularly from China to meet the bulk requirement of various drugs including essential drugs and Active Pharmaceutical Ingredients (APIs), if so, the details thereof and the reasons therefor; and
- c) the measures taken by the Government to boost export of medicines/ drugs and encourage the Indian Pharmaceutical companies to increase their production so as to reduce dependence on imports?

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF LOK SABHA
STARRED QUESTION NO. 69 FOR ANSWER ON 27TH FEBRUARY, 2015
REGARDING “EXPORT/IMPORT OF MEDICINES/DRUGS”**

- (a) Commodity-wise/country-wise India's import and export of APIs during last three years and current year for the top 30 markets is enclosed at Annexure I & II respectively.
- (b) : The estimated production of bulk drugs by indigenous drug manufacturing companies in 2013 was US\$ 10.4 billion and import was US \$ 3.5 billion. As per the reports available, in case of 12 essential drugs namely; Paracetamol, Metformin, Ranitidine, Amoxicillin, Ciprofloxacin, Cefixime, Acetyl salicylic acid, Ascorbic acid, Ofloxacin, Ibuprofen, Metronidazole and Ampicillin, there is significant dependence on imports for drug ingredients; substantial imports are from China. One of the reasons for imports from China is the competitiveness of these products.
- (c) The Government is taking several measures to boost exports under MDA & MAI schemes. India is one of the largest manufacturers of medicines and exports to more than 200 countries. Taking into account the dependence of Indian drug industry on import of APIs, a Committee was constituted to study and identify the Active Pharmaceutical Ingredients (APIs) of critical importance and to consider a measures required to build domestic production capabilities etc. The committee has in its findings, inter-alia, reported that the API industry in the country has to be made more viable and there is a need for building an eco system to promote investment in the sector, based on global practices. There are also recommendations for improving the regulatory regime in the country.

- b) the country's share in world export of processed/value added agricultural products along with the share of States therein, State/UT-wise;
- c) whether there has been decline in export and rise in import of such products during the said period due to shortage of such products in the country;
- d) if so, the details thereof along with the other reasons for gap in its export and import; and
- e) the steps taken by the Government to boost export of such products and check waste of perishable products in the country?

- (a) The quantum and value of processed/value added agricultural products exported and imported during the years 2011-12 to 2013-14 and 2014-15 (Apr-Dec) is at **Annexure I and II** respectively. Country wise details (top 5) in respect of export and import of top 5 such commodities/products is at **Annexure – III & IV** respectively. Variety wise data is not maintained.
- (b) Data on India share in world export of processed/value added agricultural products is not maintained. State/UT wise and variety wise details of such exports are also not maintained centrally.
- (c & d) Export and import of agricultural commodities including processed and value added agricultural products depends on various factors including availability of surplus over and above the domestic requirement, international demand and supply situation, quality standards, varieties traded and price competitiveness etc.
- (e) APEDA under the administrative control of the Department of Commerce is implementing various schemes to extend financial assistance to the eligible exporters registered with it to boost the overall agri products exports. Besides these measures, the Ministry of Commerce and Industry has put in place various schemes namely Market Development Assistance (MDA), Market Assistance Initiative (MAI), Assistance to states for Developing Export

Infrastructure and Allied Activities (ASIDE), Vishesh Krishi and Gram Upaj Yojna (VKGUY), Focus Product Scheme, Focus Market Scheme, Town of Export Excellence etc. to provide assistance to encourage exports in general. Trade delegations are also mounted to penetrate foreign markets and Buyer-Seller Meets are also organized to assist potential exports.

- (a) to (d): In the World Trade Organization (WTO) dispute DS430 (Measures Concerning the Importation of Certain Agricultural Products from the United States), the WTO Panel had ruled that the import restrictions, imposed vide the Government of India (GOI) Notification No. S.O. 1663(E) dated 16 July, 2011, on account of outbreak of Avian Influenza in the country of export, is inconsistent with the WTO Agreement, in particular, the Agreement on Sanitary and Phytosanitary (SPS) Measures.

GOI has filed Appeal before the WTO Appellate Body on certain rulings of the panel which GOI considers legally inconsistent with the WTO Law.

India has a system in place for import of poultry products through Sanitary Import Permits (SIP). SIPs are granted for import of poultry products only after detailed Risk Analysis from the angle of human and animal safety. Import of poultry products are allowed from the country which are free from Highly Pathogenic and Low Pathogenic Avian Influenza. Moreover, at present, the Customs Duty on chicken legs has been retained at India's bound rate of duty, which is the maximum permissible level of duty committed to the WTO.

- (c): No. In the case of cardamom 95% of the produce is selling through the auction system, implemented by Spices Board. The traders who are registered with Spices Board are actively participating in the auction system and no cardamom is lying in the warehouses of Spices Board.

(a) : The details of EOUs presently functional in the country are furnished in Annex-I.

Proposals for setting up units under EOU scheme are considered by the Unit Approval Committee taking into account factors such as residence proof, Income Tax return of all the promoters for the last three years, experience of all promoters, marketing tie-ups etc.

Further, as per the provisions of Para 6.6.2 of the Foreign Trade Policy only projects having a minimum investment of Rs. 1 crore in plant and machinery can be set up under Export Oriented Unit (EOU) scheme. This condition does not apply to proposals for Handicrafts, Agriculture, Floriculture, Aquaculture, Animal Husbandry, Information Technology, Services, Brass Hardware and Handmade jewellery sectors. The Board of Approval (BOA) can also allow establishment of EOUs with a lower investment criteria on a case to case basis.

(b) : Yes Madam.

(c) : The number of proposals received as well as approved by the Government for such units during each of the last three years and the current year, State/UT-wise are as per Annex-II.

(d) and (e) : Exports made by these units for the year 2013-14 amounted to Rs. 82072.71 Cr. i.e. 4.3% of the total exports of the country in the said year.

To boost exports by EOUs, various incentives are being provided by the Government under Chapter 6 of Foreign Trade Policy in addition to the Central Customs and Excise Act, Rules and Regulations. These may be broadly listed as under:

- (i) Duty free sourcing of inputs including capital goods.
- (ii) Procurement of goods from Domestic Tariff Area (DTA) without payment of Central Excise Duty.
- (iii) Supplies by DTA manufacturer are eligible for deemed export benefits under Chapter 8 of Foreign Trade Policy.
- (iv) Full reimbursement of Central Sales Tax.
- (v) Central Value Added Tax (CENVAT) on service tax paid.
- (vi) DTA sale (including advance DTA Sale) upto 50% of F.O.B. value of. Physical Exports permitted on payment of concessional rate of duty.
- (vii) FDI upto 100% permitted as per the guidelines of Department of Industrial Policy and Promotion.

There is a mechanism to monitor and prevent the misuse of the concession granted to the EOUs which is implemented through a joint control by the Ministry of Commerce (represented by the Development Commissioner) and the Ministry of Finance (represented by the Commissioner, Central Excise, Customs & Service Tax). There is statutory framework to monitor and prevent misuse of the EOU scheme through legal provisions made under the provisions of Foreign Trade (Development & Regulation) Act 1992, Customs Act 1962, Central Excise Act 1944 and Rules made thereunder. In the event that any EOU found violating any norm such as non/short fulfillment of export obligation, excess and inadmissible imports irregular and unauthorized DTA sales, excess reimbursement of CST, drawback on DTA sales, non-realization of export proceeds, irregular de-bonding, non-receipt of re-warehousing certificates, etc. duty exemptions are withdrawn and necessary recoveries are made after following due process of law in addition to imposition of penalties etc. as per provisions of Foreign Trade (Development & Regulation) Act, 1992, Customs Act 1962, Central Excise Act 1944 and Rules made there under.

- a) The quantum and value of trade (export-import) between India and the United States of America (USA) since 2011-12 is attached as Annex- I to III and between India and Latin American Countries including Mexico as Annex-IV to VIII.
- b) & c) Yes, Madam. During the visit of US President to India on 25-27 January, 2015, India and USA agreed, inter alia, to continue to strengthen their broad-based partnership for development through stronger trade, technology, manufacturing, and investment linkages between the two countries through a Joint Statement released during the visit.

d) In order to improve investors confidence to realize the full potential of trade and commercial relations, India and USA continuously interact through two Institutional Mechanisms of India-US Trade Policy Forum and India-US Commercial Dialogue for enhancing trade and commercial relations. During the recently held 8th India US Trade Policy Forum in New Delhi in November, 2014, a range of issues including Market Access issues relating to Agriculture products, Services and Investment issues including Totalisation Agreement, Promoting Investment in Manufacturing were discussed and in the elevated India-US Commercial Dialogue, both sides have agreed in expanding the Dialogue and exploring new areas of cooperation, including Investment Promotion and SEZs; Building Capacities and Institutional Linkages between Premier Institutions especially in the field of Technical Textiles, sharing best practices and exploring technologies related to corrosion prevention and control and encouraging the private sector to work with the Governments on roundtables to promote innovation in advanced manufacturing.

For realizing the full potential of trade and commercial relations between India and Latin American Countries, FOCUS LAC Programme was launched in 1997 which has been extended upto March, 2019. India has also signed two Preferential Trade Agreements, one with Chile and the other with MERCOSUR countries of Brazil, Argentina, Paraguay and Uruguay. A Joint Study Group has been constituted with Peru for assessing feasibility of an Free Trade Agreement, and negotiations have been completed for expanding India-Chile Preferential Trade Agreement.

(a) & (b): Presently, there is no such proposal.

(c): Spices Board implements various export promotion schemes such as technology and process upgradation, setting up/upgradation of in-house quality controls, quality certification and training of laboratory personnel, providing assistance to the farmers for the post-harvest quality improvement through various quality improvement programs and imparting training to the farmers in Good Agriculture Practices for producing quality spices. The Spices Board has established 6 state of the art Quality Evaluation Laboratories in almost all the major port cities viz. Mumbai, Chennai, Cochin, Tuticorin, New Delhi and Guntur to evaluate the quality of spices exported from the country. The Laboratory provides analytical services to the Indian Spice Industry and also undertakes analysis of consignment samples under the mandatory inspection of Spices Board. Codex Alimentarius Commission has formed an exclusive Codex Committee on Spices and Culinary Herbs (CCSCH) with India as Chair. The Secretariat of the CCSCH is now functioning in Spices Board to elaborate worldwide standards for spices and culinary herbs in their dried and dehydrated state in whole, ground, and cracked or crushed form.

- (a) India has not entered into any new Free Trade Agreement (FTA) or Preferential Trade Agreement (PTA) during the last three years. However, India expanded the scope of the Free Trade Agreement (FTA) with ASEAN to Services and Investment on 09.09.2014 with its date of implementation as 01.07.2015.
- (b) Does not arise.
- (c) The Government is negotiating new FTAs and expansion of existing FTAs with some countries, including Israel.

(d) The FTA negotiations are a continuous process and it is difficult to predict a time-line for conclusion. The list of 17 ongoing negotiations along with their status is at **Annexure-I**.

(e)&(f): Before entering into negotiations with its trading partners, studies are undertaken internally, as well as through the Joint Study Group (JSG) to study the feasibility of the proposed FTAs, including their impact on the domestic industry and agriculture sector. Consultations are also held with the domestic stakeholders including the Apex Chambers of Commerce and Industry, Industry Associations as well as the Administrative Ministries and Departments. In order to protect the interest of the domestic industry and agriculture sector, these agreements provide for maintaining sensitive/negative lists of items on which limited or no tariff concessions are granted under the FTA. In addition, in case of a surge in imports and injury to the domestic industry, a country is allowed to take recourse to the measures such as anti-dumping and safeguards.
