REGARDING “DUTY FREE TARIFF PREFERENCE SCHEME”**

a): Yes, Madam.

- b) Pursuant to the Hong-Kong WTO Ministerial Declaration of December 2005 for Duty Free Quota Free access to the Least Developed Countries (LDCs), India announced its Duty Free Tariff Preference (DFTP) Scheme for LDCs in the year 2008. The Scheme came into full operation in 2012 and provided duty free access on about 85% of India's total tariff lines and preferential access (Positive List) on about 9% of the tariff lines. Only 6% tariff lines were under the Exclusion List.

Further, to fully meet the obligations under the Hong Kong Ministerial Mandate, the Scheme has been expanded and with effect from 1.4.2014, the Scheme now provides duty free market access on about 96 % of India's tariff lines and 2.2% of the lines are enjoying preferential duties. Only 1.8% of the tariff lines have been retained in the Exclusion List, with no duty concessions.

In order to become beneficiary of the DFTP Scheme, individual LDCs are required to submit to the Government of India, a Letter of Intent and details of officials who would be responsible for issuing the Certificate of Origin in the prescribed format.

- c) At present, 31 LDCs have become beneficiaries of the Scheme. These are- Benin, Malawi, Burkina Faso, Mali, Burundi, Mozambique, Comoros, Rwanda, Central African Republic, Senegal, Eritrea, Somalia, Ethiopia, Sudan, Gambia, Uganda, Lesotho, Tanzania, Liberia, Zambia, Madagascar, Afghanistan, Myanmar, Bangladesh, Samoa, Cambodia, Republic of Yemen, East Timor, Maldives, Lao PDR, Haiti.
- d) No, the Government has not evaluated the impact of DFTP Scheme on the domestic Indian market. It is pertinent to note that the share of beneficiary LDCs' imports, as a percentage of total imports by India is only 1.17% in 2013-14.

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF LOK SABHA

REGARDING “BAN ON IMPORT OF ASBESTOS”**

(a): There is no world-wide ban on manufacture and usage of asbestos. Countries like Russia, China, Brazil, Kazakhstan and Canada are large producers and exporters of asbestos.

(b) to (d) No. India is a signatory to the Rotterdam Convention which regulates International Trade in Hazardous Chemicals and Pesticides (Annex III of the Convention) on health or environmental reasons. Asbestos consists of six varieties, namely, Crocidolite, Actinolite, Anthophyllite, Amosite, Tremolite and Chrysotile. Except Chrysotile variety of asbestos, import of first five varieties is “Restricted” in the Country (requiring import licence) as per the Rotterdam Convention, whereas Chrysotile variety has not been listed in Annex III and its import policy is “free”. No authorisation/licence has been granted during 2011-2015 to import any of the 5 “Restricted” varieties of asbestos.

The following remedial steps have been taken by the Government for regulation and safe use of Asbestos:

- (a) As per the provisions of the Factories Act, 1948 and rules framed there under, manufacture, handling and processing of asbestos and its products is declared as hazardous process.
- (b) Govt. of India has prepared Schedule XIV – Handling and Processing of Asbestos, Manufacture of any Article or Substance of Asbestos and any other Process of Manufacture or otherwise in which Asbestos is used in any form as a dangerous operation under section 87 of the Factories Act, 1948.
- (c) Govt. of India by Notification in Official Gazette has reduced the permissible level of Air borne Asbestos fibres in work environment to 20.1 fibre/cc.
- (d) Grant of fresh mining leases and renewal of existing mining leases for Asbestos was banned by the Ministry of Mines in the country on Health Grounds.

EXPORT OPPORTUNITIES FOR INDIA

- a) whether there is new export opportunities for the country under the Indo-Korea Comprehensive Economic Partnership Agreement (IK-CEPA);

- c) the advantages of Indian goods in the Korean market and the benefits accrued to Indian service suppliers under various categories of 'Other Business Services' in the said agreement; and
- d) the manner in which the Government is likely to tap these opportunities?

(a) to (d): Yes, Madam. India and the Republic of Korea signed a Comprehensive Economic Partnership Agreement (CEPA) on 7th August, 2009, which has come into force from 1st January, 2010. The Comprehensive Economic Partnership Agreement covers a number of areas including trade in goods, trade in services, rules of origin, intellectual property rights, investment, etc. The agreement promotes stronger trade and commercial ties between two countries, and opens up opportunities for exporters and investors to expand their business in the tariff lines which are opened or in which tariff is reduced. During the period 2009-10 to 2013-14, bilateral trade between the two countries increased from US \$ 12 billion to US \$ 16.68 billion, including increase in Indian exports from US \$ 3.42 billion to US \$ 4.20 billion. There are export opportunities for several Indian products in Korean market including, inter-alia, mineral fuels/ mineral oils, iron and steel, organic chemicals, aluminium and articles thereof, residues and waste from food industries, cotton products etc. In services sector, India has negotiated a 'Trade in Services' chapter under India-Korea CEPA wherein Korea has taken commitments in a number of sectors/sub-sectors that are commercially meaningful for India. Under sub-sector "Other Business Services", Korea has taken commitments in many services including, inter-alia, advertising, management consulting, project management, technical inspection, placement of personnel etc., the benefits of which is available to Indian service suppliers. The Government on its part organises outreach programmes in various parts of the country to spread awareness among the Industry people/exporters/ service providers about the opportunities available under India-Korea CEPA to boost exports to Korea.

- b) the country's share in production of spices in the world along with share of various States/UTs therein;
- c) whether the production of spices is less than demand in the country, if so, the details thereof and the reasons therefor;
- d) the details regarding quality and prices of spices in the country during the said period; and
- e) the measures taken/to be taken by the Government to boost production of spices?

(a): The total production of spices is around 6 million tonnes in the country, out of which only 11% is exported and the rest is internally consumed. Estimated domestic consumption of major spices in the country is given as Annex-I. State-wise data of demand and domestic consumption is not maintained.

(b): India's share in the production of major spices in the world is estimated as 30%. State-wise share of major spices in the world production is given as Annex-II.

(c): In the case of tree spices like Clove, Cinnamon/Cassia, Star anise etc., India is a traditional net importer as our production of these spices is not sufficient for internal consumption. India also imports a few selected spices such as Light Pepper with high piperine content, Turmeric with high curcumin and Chilli with high colour value for value addition and re-export by the processing industry especially the oleoresin extraction industry.

(d): Domestic prices of major spices in the country for the last three years are given in a statement as Annex- III.

(e): Government, through the Spices Board implements several development and promotion programmes including development of infrastructure for common processing facilities in Spices Parks, adoption of upgraded technology in spice processing, setting up of quality evaluation labs, quality certification and training of laboratory personnel, providing assistance

to the farmers for post-harvest quality improvement, imparting training to the farmers in Good Agriculture Practices etc. for producing quality spices.

(a) The details of the trade balances/ imbalances at the time of commencement of Free Trade Agreements are given at Annexure 1.

(b) and (c): The issue of trade imbalances with our trading partners and the concessions sought are taken up bilaterally with the respective countries through institutional mechanisms which are in place with the countries. The review of Agreements are undertaken to review the imbalances and implementation issues to optimize the potential of the Agreements.

Continuous efforts are made to bridge the trade imbalances through export incentive measures. The Government assesses the export performance on a continuous basis and need based corrective measures to boost exports are taken from time to time. The Government is providing a policy environment through a mix of measures including fiscal incentives, institutional changes, procedural rationalization and efforts for enhanced market access across the world and diversification of export products. Trade promotion activities are organised, from time to time, in various countries with which India has trade agreements.

The collaborative projects are aimed at evolving improved coffee varieties having resistance to major pest, diseases and drought and developing technologies for coffee production through improved soil health, management practices and eco-friendly measures.

One of the Growers' Associations viz., Karnataka Planters' Association had organized study tours to Vietnam, Brazil and Israel for the benefit of its grower members from 2011 to 2013.

- (a) : Quantum and value of arecanut exported and imported during each of the last three years and the current year, country – wise is at Annexure-I & II respectively.
- (b) & (c): The monthly average price of arecanut recorded in Kozhikode and Sagar Markets is at Annexure-III. The mean average price has generally shown an upward trend.
- (d) & (e): Representations have been received for increasing the minimum import price and restrict/prohibit/impose duty on the import of arecanut from South East Asian Countries in view of alleged illegal import of inferior quality areca nuts through neighboring Countries, causing fall in domestic prices.

The issue of increase in the minimum import price of arecanut has been examined in consultation with the Ministry of Agriculture & Cooperation. Taking into consideration the production figures and the import, domestic prices of the item in the country and considering that the quantity of arecanut import is small as compared to domestic production, no justification has been found for increasing the present Minimum Import Price (MIP) of arecanut (Rs.110/- per kg) .

(f) To check/restrict import of arecanut and address the grievances of arecanut growers, the Government, besides fixing the minimum import price of arecanut at Rs.110/- per kg, has laid down that imports of arecanut would be permitted as an input under advance authorisation, only when it is by an actual user or by anybody (including the actual user), if it is specifically mentioned in the standard input output norms. Further, while the present import duty of arecanut on MFN basis is 100%, Central Board of Excise & Customs also imposes a tariff value on the import of arecanut. In addition, Department of Revenue have been requested to increase vigil and monitoring of imports of arecanut to ensure compliance with Rules of Origin.

(a) & (b): The workers and their dependents in tea gardens are provided basic welfare services and amenities e.g. housing, medical and primary education, water supply, sanitation etc. under the Plantation Labour Act, 1951. The Act provides for compensation only to a worker in plantation in case of accident in accordance with the provisions of the Workmen's Compensation Act, 1923.

Besides, the government implements through the Tea Board various welfare activities for tea plantation workers and their dependants in tea estates. The welfare activities undertaken by the Tea Board under the Human Resource Development (HRD) Scheme aim at improving the health and hygiene of workers, education of wards of workers and imparting training to improve skills for growers/workers.

Under the health and hygiene programme, financial support is provided for augmenting the infrastructure of the tea garden hospitals/health centres and procurement of medical equipment, and accessories, ambulance etc. Family welfare education programme and scouting and guiding activities are also supported for the benefits of children of the workers. Financial assistance is given to physically challenged plantation workers and their wards by providing crutches, caliper shoes, artificial limbs etc.

Under the Education and Training support programme, books, uniforms and educational stipends are given to the wards of workers. Vocational training programmes are organised for skill improvement and self employment of the dependants of the workers.

During the XI Plan Period (2007-12) the total amount disbursed for these purposes by the Tea Board was Rs.20.15 Cr. During the first two years of the XII Plan i.e. 2012-13 and 2013-14, the Board has spent Rs.14.31cr.and Rs.8.93 Cr. respectively on such programmes.

- (c) The cost of sugar production depends upon a number of factor like cost and quality of raw material mainly sugarcane, conversion cost, efficiency of plant and Machinery etc. The cost of such inputs varies from country to country. Besides, in Brazil, the mill owner have major share of their own land holdings for cultivating sugarcane whereas in India cane is grown and supplied to mill by Indian farmers having small land

holdings. The policy of cane pricing in Brazil are linked to prices of sugar and ethanol whereas in India Central Government fixes Fair and Remunerative Price (FRP) of sugarcane which is minimum price to be paid by sugar mills to farmers. These are some of the reasons for higher cost of sugar production in India.

- (d to f) The apex bodies of the sugar industry i.e. Indian Sugar Mills Association (ISMA) and National Federation of Cooperative Sugar Factories Ltd (NFCSF), have request the Government to provide subsidy on marketing and promotion services of raw sugar production linked to export market. The Central Government vide notification dated 28.02.2014 has allowed to provide incentive for export of raw sugar during 2013-14 sugar season which was subsequently extended for the current sugar season 2014-15 vide notification dated 27.02.2015. During current season the incentive is available @ Rs. 4000 per MT upto a maximum of 14 Lakh MT.

There are no provisions under the Drugs and Cosmetics rules, 1945 which requires CDSCO to ensure the said compliance by the Indian Pharmaceutical companies. Hence CDSCO has no information with respect to corrective steps for resolving these issues. However, respective countries accord their own approvals after inspecting plants located in India.

- The coconut and its products including coir are incentivised at the rate varying from 2% to 7% under Focus Product Scheme. They are also incentivised at the rate varying from 3% to 4% under Focus Market Scheme. Exporter can claim any one benefit
- Excise duty on handmade carpets and textile floor covering of coir and jute products has been exempted.
- The drawback benefits have been increased for Coir Geotextiles from 1.7% to 1.9% and Coir Floor coverings from 3.2% to 4.9%.

As shown in the above table the trade deficit has varied over the period. Chinese exports to India rely strongly on manufactured items meeting the demand of fast expanding sectors like telecom and power. India's exports to China are characterized by primary products, raw material and intermediate products. The exports to China face tariff and non-tariff barriers for agricultural products, and limited market access in other products.

(c): Manufactured items catering to India's Power, Telecom, and other fast growth sectors contribute a significant proportion towards China's imports into India. Other major imports are of products such as computer hardware and peripherals, bulk drugs and drug intermediates, project goods, fertilizers and chemicals, consumer electronics, iron and steel and products thereof etc. These imports feed the growing demand in India for such goods which China, due to variety of reasons, is able to export to India at competitive prices. The Government, mindful of the interest of domestic manufacturers has continually taken steps to ensure that all imports into India strictly adhere to the applicable domestic laws and regulations pertaining to technical specifications, environment and safety norms, which are notified from time to time. Appropriate action is initiated in case of violation of these norms. Furthermore wherever Indian industry faces a threat or is seriously injured due to surge in imports of a particular product, appropriate trade remedy measures are immediately initiated. Directorate General of Anti-Dumping and Allied Duties (DGAD) has initiated 171 investigations on imports from china and anti-dumping measures are in force on 75 products, as at end of February 2015.

(d): Yes, Madam. Representations received in this regard were examined and taken into consideration by the Department of Revenue while finalising the proposals for the Union Budget 2015-16.

(e): In order to boost exports and to address the widening trade deficit Government has taken a number of measures which, inter-alia, include market study initiatives to identify specific product lines with export potential, actively taking up issues relating to tariff and non tariff barriers in bilateral meetings and institutional dialogues, measures to support exports through various incentive measures and product and market specific incentive schemes etc. As regards trade with China, India has impressed upon China to recognise the need for reduction in trade imbalance for a long term, sustainable and harmonious development of economic co-operation between two countries. During the 10th meeting of the India-China Joint Economic Group (JEG) at Ministerial level, held in September 2014 in Beijing, both countries reaffirmed their determination to expand and diversify bilateral trade and economic cooperation. The two sides agreed to take positive steps towards rebalancing bilateral trade and addressing the existing structural imbalance in trade that has a bearing on its sustainability. Both countries signed the "Five-Year Development Program for Economic and Trade Cooperation" wherein reduction of trade imbalance over the next 5 years has been

identified as one of the principal objectives of trade and economic co-operation between India and China.

All imported goods in India are subject to domestic laws, rules, orders, regulations, technical specifications, environment and safety norms, that are notified from time to time. The Government takes appropriate action in case goods imported from any source are found to violate these regulations and threaten human, animal or plant life or health. Additionally, Directorate General (Safeguards) is empowered to temporarily restrict import of products by imposition of additional duty or quantitative restrictions (QRs) if Indian industry is seriously injured or threatened with injury caused by a surge in imports.

- (a) The Government regulates the production of FCV tobacco through the Tobacco Board which has been set up under the Tobacco Board Act, 1975. One of the important mandates of the Tobacco Board is to regulate the production through fixation of crop size for FCV tobacco.
- (b) India is a signatory to WHO's Framework Convention on Tobacco Control (FCTC) whereby there is an obligation to implement the provisions of FCTC in India to reduce the consumption of tobacco. Further, appropriate supply management helps in ensuring remunerative prices to the growers.
- (c & d) The Government has stopped issuing new industrial licenses for manufacturing of Cigarettes, Cigars, Cigarillos, Cheroots of tobacco and tobacco substitutes since 1999 on grounds of health.

(a) : State-wise production of tea and coffee during the last three years and the current year are detailed in **Annexure-I**. Domestic consumption of these crops during the last three years and the current year are detailed in **Annexure-II**. State-wise data of domestic consumption are not maintained by the Government.

(b) : Quantum and value of export and import of tea and coffee during last three years and current year in respect of major destinations and origin countries are given in **Annexure-III** and **Annexure-IV** respectively.

(c): Share of India in total world production of tea and coffee was 25 percent (in 2013) and 3.56 percent (in 2013-14) respectively. The share of India in total world export of tea and coffee was 11.76% (2014) and 4.60% (in 2013-14) respectively. The state-wise share of coffee production percentage during 2013-14 to the total production is given below:

The state-wise data of tea and coffee exports is not maintained by the Government.

(d): Production and exports of tea during the last three years have grown. During the current year 2014-15 (Apr-Dec), both the production and export of tea declined compared to its corresponding period in 2013-14 due to adverse weather climate prevailing during April-June 2014. Decline in export of tea is attributable to loss of Assam Orthodox tea production during peak season, lower price of teas from Africa in the world market and fall in demand in high-value markets such as USA, Iran, Russia and Bangladesh.

There has been a gradual increase in the production of coffee in the country. However, production was 4.3% less in 2013-13 as compared with 2012-13 due to adverse weather conditions coupled with unpredictable and erratic rainfall. However, the coffee exports have shown increase from year to year.

(e) The Financial assistance provided by the Government to tea and coffee growers, particularly to small tea growers of Assam during last three years are given in **Annexure-V**.

(f) : Government has taken measures to boost the production and export of tea and coffee through the Tea and Coffee Boards which provide financial and technical assistance to the growers and the industry for new planting, replanting, rejuvenation, quality up-gradation, value addition and market promotion. The schemes to promote export of plantation crops envisage providing assistance for participation in trade fairs, exhibitions, buyer-seller meets, brand promotion, presenting export awards, public relation campaigns and incentives for export of value added products.

- a) whether the Government has taken note that Chinese consumer goods are available in North-East States in all markets i.e. from kiosks to mall;
- b) if so, the details thereof;
- c) whether these goods are coming through proper channel;
- d) if not, the measures taken by the Government to channelise it; and
- e) whether any Chinese investment has been made in North-East States, particularly in Assam and if so, the details thereof?

(INDEPENDENT CHARGE) (SMT. NIRMALA SITHARAMAN)

(a) and (b) - All goods being imported from any country (including China) into India (including North East States) are subject to prescribed procedure and regulatory checks and have to abide by domestic laws, rules, orders, regulations, technical specifications, environmental and safety norms. India has removed all Quantitative Restrictions on imports, except those necessitated mainly on grounds health security, public morale and environment. However, adequate provisions exist to protect the Indian consumers and producers e.g. imposition of Minimum Import Price, Customs Duty and Qualitative Restrictions etc.

(c) and (d) - As regards goods smuggled illegally into the country the primary responsibility of preventing entry of smuggled goods into India lies with Indian Customs, supported by security agencies. Penal action is initiated under the provisions of Customs Act, 1962 read with other allied Acts in case of any violation. The Government of India has also taken various measures for checking sub-standard imports, which inter-alia include the following:

- i. Government has imposed prohibition on import of milk and milk products (including chocolate and chocolate products and candies/confectionary/food preparations with milk or milk solids as an ingredient) from China since 01.12.2008, which has been extended from time to time and these products are currently prohibited till 23.06.2015.
- ii. Import of toys is subject to quality standards prescribed in the Foreign Trade Policy.
- iii. Government has imposed prohibition on the import of mobile handsets (mobile phone) without International Mobile Equipment Identity (IMEI) No. or with all zeroes IMEI and import of CDMA mobile phones without Electronic Serial Numbers (ESN), Mobile Equipment Identifier (MEID) or all zeroes ESN/MEID.
- iv. Government has also notified products under compulsory certification/registration with one of the objective of checking influx of substandard products into the Indian markets.

- (e) As per the DIPP database, FDI equity inflow received at Guwahati Regional Office (covering Assam State) from China are NIL.

(c) to (e) There was no decline in the exports of marine products during the last few years. To boost the marine products exports and make Indian seafood products competitive, Government of India, through MPEDA, is implementing variety of assistance Schemes, some of which are as under:-

- i) **Capture Fisheries** - for promotion of fishing of Tuna and other under exploited resources, providing interest subsidy for the construction of new tuna long liners and Assistance to fishermen for better preservation of catch.
- ii) **Processing Infrastructure & Value Addition** – providing subsidy for acquisition of machinery for tuna cannery / processing of value added tuna product, financial support for acquisition of Refrigerated Truck / Containers and setting up Large Cold Storages, etc.
- iii) **Culture Fisheries** – providing subsidy for new farm development, small and medium-scale hatcheries, setting up of PCR labs in hatcheries/Pvt. Lab, assistance for farmers for undertaking organic farming of shrimp and scampi, etc.
- iv) **Market Promotion** – providing development assistance for export of Ornamental/Aquarium Fishes/Live Aquarium Plants, Sea Freight Assistance, and insurance scheme for workers in Seafood processing units, etc.
- v) **Quality Control** – providing assistance to seafood processors for construction / renovation of captive pre-processing center with upgraded facilities, for setting up of Mini Laboratory, etc.

(c & d) As per existing Foreign Trade Policy, export of beef (meat of cow and it's progeny) is prohibited. No specific complaints of illegal beef exports has been received by APEDA.

(e) Currently there is no proposal under consideration of the Department of Commerce to ban export of meat from India.

(f) The Government has inter-alia, taken following steps to ensure compliance of the prescribed norms by the exporters:

- (i) Export of buffalo meat is allowed on production of a certificate stating that the meat is from buffaloes not used for breeding and milch purpose.
- (ii) Export of meat and meat products is allowed subject to the exporter furnishing a declaration that the above items have been obtained/sourced from an APEDA registered abattoirs or from APEDA registered meat processing plant which sources raw material exclusively from APEDA registered integrated abattoir/abattoir.

- (b) Yes. Request has been received from the industry for extension of the duty free import of pulses for another one year after expiry of the current exemption on 31st March, 2015.
- (c) Gulbarga Toor Dal' as Geographical Indication has not been registered as yet under the Geographical Indications of Goods (Registration and Protection) Act, 1999 as the Controller General of Patents, Design & Trade Marks, Mumbai under the Department of Industrial Policy and Promotion has not received any application for registration of Gulbarga Toor Dal as Geographical Indication.
- (d) India is a net importer of pulses due to mismatch between domestic production and consumption and currently export of pulses is prohibited except the export of kabuli channa (a premium variety of pulses) 10,000 MT of organic pulses per annum. The

Government has also allowed export of items covered under Chapter 7 (which includes Lentils/ Pulses) of ITC (HS) Schedule 2 under the Advance Authorization Scheme subject to certain conditions including pre-import condition.

(a): The notification of Special Economic Zones (SEZs) in the country is guided by the following:-

- i. generation of additional economic activity
- ii. promotion of exports of goods and services;
- iii. promotion of investment from domestic and foreign sources;
- iv. creation of employment opportunities;
- v. development of infrastructure facilities

A statement showing the State/UT-wise, list of SEZs is at **Annexure-I**.

(b): The fiscal concessions and duty benefits allowed to Special Economic Zones (SEZs) are in-built into the SEZs Act, 2005 and Rules thereunder. The incentives and concessions available to SEZ Developers and Units include exemptions from income tax, customs/excise duties, central sales tax, service tax, VAT, etc. These fiscal concessions and duty benefits allowed to Special Economic Zones (SEZs) are in built into the SEZs Act, 2005 and Rules thereunder and are in the nature of incentives to achieve the SEZ objectives. The revenue foregone on account of concessions availed by the SEZ Developers and Units under the provisions of sections 10AA, 80-IA and 80-IAB of the Income Tax Act, 1961 for the last three years is as under:-

(c): Land is a State subject. Land for Special Economic Zones (SEZs) is procured as per the policy and procedures of the respective State Governments. State Governments have been advised that in case of land acquisition for SEZs, first priority should be for acquisition of waste and barren land and if necessary single crop agricultural land could be acquired for the SEZs. If perforce a portion of double cropped agricultural land has to be acquired to meet the minimum area requirements, especially for multi-product SEZs, the same should not exceed 10% of the total land required for the SEZ. The Board of Approval for SEZs only considers those proposals, which have been duly recommended by the State Government. Further, pursuant to the decision of Empowered Group of Ministers (EGOM) in its meeting held on 5th April, 2007, the State Governments have been informed on 15th June, 2007 that the Board of Approval will not approve any SEZs where the State Governments have carried out or propose to carry out compulsory acquisition of land for such SEZs after 5th April, 2007. A statement showing the State/UT-wise, total notified land area, area utilized and lying vacant in Processing Area of 365 notified SEZs is at **Annexure-II**.

(d): As on 28th February, 2015, 37 SEZs have been de-notified. Reasons given by developers for de-notification include economic meltdown, poor market response, non-availability of skilled labour force, lack of demand for space and changes in fiscal concessions regime for Special Economic Zones (SEZs).

(e): In addition to Seven Central Government Special Economic Zones (SEZs) and 11 State/Private Sector SEZs set-up prior to the enactment of the SEZ Act, 2005, approval has been accorded to 436 proposals for setting up of SEZs, out of which 347 SEZs have been notified as on date. Presently, a total of 199 SEZs are exporting. The contribution of SEZ exports, employment generated and investment made in SEZs during the last three years is as under:

- a) whether some countries including United States (US) and European Union (EU) have prohibited/restricted import of certain fruits and vegetables including Mangoes from India;
- b) if so, the details thereof and the reasons therefor;
- c) the impact of the decision on export of fruits and vegetables along with the quantum of loss of foreign exchange to the country thereby;
- d) whether any team from EU has recently visited the country to evaluate the facilities/mechanism relating to export of fruits and vegetables and if so, the details and the outcome thereof indicating the improvements made and mechanism adopted by the Government to check the quality of these products before their export; and;
- e) the further measures taken by the Government to get the said ban lifted alongwith the present status thereof?

(INDEPENDENT CHARGE) (SMT. NIRMALA SITHARAMAN)

- (a & b) Temporary ban/restriction are imposed by importing countries from time to time for non compliance of their rules/regulations/standards by exporters. The European Union (EU) had prohibited import from India of Indian mangoes and four other vegetables viz. Tarro Plant (Arbi- except root and seed), brinjal, snake gourd and bitter gourd, effective from 01st May, 2014 on account of interceptions of export consignments not compliant with EU Phytosanitary regulations. Similarly, Saudi Arabia had also imposed a temporary ban on import of green pepper from India due to the presence of pesticides residue in green pepper.

(c) India's exports of fresh fruits & vegetables during 2014-15 (Apr. – Jan.) have fallen by 14.02% in USD terms as compared to exports during the corresponding period of 2013-14. However, the decline cannot be attributed entirely to the restrictions imposed by certain countries as exports of agricultural commodities including fruits and vegetables depends on several factors such as international demand and supply situation, exportable surplus availability in the country, international and domestic price situation etc.

(d&e) European Union banned import of fruits/vegetables including mangoes from India with effect from April 2014. India had taken up this issue with EC at every possible forum. A FVO mission from EC visited India in Sept. 2014 to inspect the improved official control put in place by India for export of mangoes to EU. For improving official control for export of mangoes to Europe, a Standard Operating Procedure (SOP) has been developed by the Government for pest free export of fruits to EU wherein fruits are proposed in pack houses approved by APEDA under the supervision of Plant Quarantine before export to EU. FVO Mission have given affirmative report on improved official control system for export of mangoes from India to EU and consequently the European Commission has lifted the ban on import of Indian mango w.e.f. 12.02.2015.

In order to resume export of green pepper to Saudi Arabia, Agricultural and Processed Food Products Export Development Authority (APEDA) has put in place the following system for meeting their required standards:

- i) APEDA has approved 31 laboratories for testing of residue in food products.
- ii) Test report generated by the laboratories will be a pre-requisite for the issue of phytosanitary certificate.
- iii) APEDA recognized pack houses which has system in place to verify the traceability of the product will be used for packing and exporting of green chillies.
- iv) APEDA has identified vegetable cluster including that of green chillies, wherein GAP certified farmers are being identified for sourcing material for export.

APEDA in association with State Governments has been organising awareness/sensitisation programme for exporter and other stake-holders to improve the production of export quality fruits and vegetable.

- (a) The country wise data of top 5 destinations on quantum and value of export and import of major agricultural products, along with average rates for the last three years and the current year, may be seen at Annexure-I and Annexure-II respectively.
- (b) Rates for export/import are market determined and are not decided by the Government except in some very exceptional cases where a minimum export price

(MEP) is set up by the Government. As for quality, the exporters have to comply with the quality standards of the exporting and importing countries

- (c) As per World Trade Organisation (WTO) International Trade Statistics 2014 (based on trade in 2013), India's share in world exports and imports of agricultural products was 2.7% and 1.3% respectively. State/UT wise data is not maintained centrally.
- (d) & (e) As per WTO International Trade Statistics 2014, India ranks 6th among the leading exporters of agricultural products. Details of contribution of Agri & Allied Products in country's total exports, during the last three years and the current year, are as under: -

Keeping in view the fact that India has a large domestic consumption base for agricultural products, India's share in the world export as well as the share of agricultural exports in country's total exports cannot be termed as insignificant.

- (f) Encouraging exports of agricultural products is a continuous process. The Government is taking steps to encourage exports of agro products through measures and incentives under Plan schemes of the Commodity Boards and Export Promotion Councils. Besides these measures, the Ministry of Commerce & Industry has put in place various schemes namely Market Development Assistance (MDA), Market Assistance Initiative (MAI), Assistance to States for Developing Export Infrastructure and Allied Activities (ASIDE), Vishesh Krishi and Gram Upaj Yojana, Focus Product Scheme, Focus Market Scheme, Town of Export Excellence, etc. to provide assistance to encourage exports. The Agricultural and Processed Food Products Export Development Authority (APEDA) is mandated with the responsibility of export promotion and development of 14 scheduled products. APEDA participates in 10-12 international trade fairs every year to promote the export of agro products from India. APEDA also works with the regulatory bodies in the importing countries to negotiate and achieve market access for Indian agro products. To enhance the capabilities of the exporters, APEDA extends financial assistance for market, quality and infrastructure development to registered members under the plan scheme "Agriculture Export Promotion Scheme".

(a): State/UTs-wise total area under cultivation of four commercial plantation crops, namely, tea, coffee, rubber and spices are detailed in **Annexure-I**.

(b): Production and consumption of these crops in the country during the last three years and the current year are detailed in **Annexure-II** and **Annexure -III** respectively. State-wise data of domestic consumption of commercial crops are not maintained except for Natural Rubber.

(c) : State/UT-wise quantum and value of export of commercial crops during last three years and the current year are given in **Annexure-IV**.

(d) : Government has taken measures to boost the production and export of plantation crops through the Plantation Commodity Boards for tea, coffee, rubber, and spices which provide financial and technical assistance to the growers and the industry for new planting, replanting, rejuvenation, quality up-gradation, value addition and market promotion. The schemes to promote export of plantation crops envisage providing assistance for participation in trade fairs, exhibitions, buyer-seller meets, brand promotion, public relation campaigns and export of value added products.
