Subject: -Major Achievements of the Department of Commerce during May 2020.

I. Trade

- The merchandise trade deficit for April, 2020 was estimated at USD 6.76 billion as against the deficit of USD 15.33 billion in April 2019.

II. Export Promotion Councils

- PEPC circulated information about sixty-six (66) upcoming projects to its members in May, 2020.
- The representation of Pharmexcil and Farma exporters has been taken up with Ministry of Finance and DGFT about the requirement of RBI to issue a notification to direct the Banks for extending the facility of rate equalisation under the interest Equalisation Scheme for exporters on pre and post shipment credits keeping in view that DGFT has extended the validity of the scheme up to 31st March 2021 as a component of the FTP (2015-2020). RBI has issued the circular directing the banks and problem stands resolved.
- On the request from various countries for procuring Hydroxychloroquine and Paracetamol and based on the recommendations of MEA, DGFT has granted exemptions to export HCQ to 111 countries and Paracetamol to 23 countries till May, 2020.

III. Bilateral Cooperation

- As a result of close coordination with the Missions, in May 2020, after discussion with the CG-NY, FT-NAFTA Division received the list of top 500 and apparel importers of USA, and other 500 top US leather importers textile with contact details, volume and value of exporters, etc., which has been shared with EPCs for reaching out to our exporters.
- Covid-19 has led to increased trade and cooperation between India and the U.S. with India making gestures such as relaxation of export restrictions on 24 APIs and hydroxychloroquine. Three USA companies are currently engaged with their Indian counterparts for mass production of COVID-19 vaccines in India, Serum Institute of India with Codagenix of USA; Bharat Biotech of India with FluGen of USA. Similarly, U.S. company Gilead has also signed voluntary licensing agreements with four Indian companies for production of generic of the COVID drug remdesivir and its export to the 127 countries, which will provide India an opportunity to seize larger share of global pharmaceutical supply chain.

- After much persuasion by DoC, negotiations personally led by Hon'ble CIM, Indonesian side had announced an enhanced annual quota of 1,70,000 MT for Indian bovine meat in the current year which is a substantial increase compared to the 75000 MT allotted last year. In addition to the existing single agency, Bulog, another two State Owned Enterprise, Bedikari& PPT have also been engaged to buy bovine meat from India. which was also a long-standing demand of India.

V. Plantation

- The Tea Board organized a special initiative for fine plucking of tea leaves to symbolize high 'Quality Tea' of India on the occasion of International Tea Day on 21st May, 2020 wherein 300 tea companies across India took part in this special exercise with their best teas plucked to commemorate the event.
- The Rubber Board, in backdrop of COVID 19, chalked out a scheme to extend financial support to growers for rain guarding, which is very crucial for enhancing production. Hence, the Board launched a scheme through Regional Offices with a target of 25,000 ha and an outlay of Rs. 4 crore and took a lead role to make available short-term loans with interest free/nominal interest from Banks, especially in the Co-operative sector. The Rubber Board companies also offered credit facility to growers by supplying rain-guarding materials at credit which will be adjusted later against the cost of latex/sheet.
- The Rubber Board continued activities uninterruptedly in six Board's Nurseries in Kerala and three in North Eastern region for generation of quality planting material and distributed around 20,000 advanced planting materials to growers during May, 2020.
- The Rubber Board chalked out and implemented an action plan to procure rubber from small and marginal farmers through Rubber Board promoted companies and provided a short-term loan to Rubber Board companies for procurement of rubber and procured around 100 MT of RSS4 grade sheet during May, 2020, as the dealers abstain from purchasing rubber from growers due to COVID-19 lockdown.
- As in the present Covid -19 pandemic scenario, Government of India directed to close down all Training Institutions to contain its spread, the Rubber Board cancelled all calendared programmes and PMKVY programmes scheduled during the month of May, 2020. However, Rubber Training Institute undertook technology initiatives and launched the webinar series on various topics viz. (i) Talk on "Post COVID scenario—Challenges and Opportunities"— Stakeholder perspective and Employees perspective by the Executive Director, Rubber Board (ii) Talk on "Coping with COVID 19-Global Rubber Scenario" by Mr. Jom Jacob, Senior Economist, ANRPC, Kuala Lumpur (iii) Talk on "Indian Rubber Industry in the post COVID 19 Scenario – R&D strategies for self-reliance" by

Dr. James Jacob, Director, RRII and (iv) Talk on “*Coping with COVID 19– Strategies for effective management of rubber plantations*” by Dr. C.Kuruvilla Jacob, former Director (Training), RTI to maintain the sector vibrant & motivate the grower and about 450 beneficiaries from different stakeholders of the rubber industry attended in May, 2020.

- The Rubber Training Institute (RTI) conducted on-line training on Rain Guarding benefitting 53 growers and completed all the documentation works in connection with the renewal of the QMS - ISO 9001:2015 and also submitted proposed exclusive training projects for SC/ST beneficiaries under SCSP/TSP schemes for 2020-21.

VI. **APEDA**

- Agricultural & Processed Food Products Export Development Authority (APEDA) has formed Export Promotion Forums (EPFs) for seven products for a more focussed approach for identifying interventions required to boost the exports of each individual product. Chairman, APEDA is the chairman of these EPFs and these forums have representation from trade/industry, D/o Commerce, DAC&FW /DAHD, concerned State Governments, Research Institutes etc. The EPFs have been formed for the following products:
