Minutes of the Meeting of the Empowered Committee (EC) of the Market Access Initiative (MAI) Scheme, held at 3:00 PM on 24th November, 2025.

A meeting of the Empowered Committee (EC) of the Market Access Initiative (MAI) Scheme was held at 3:00 PM on 24th November, 2025 under the Chairmanship of the Commerce Secretary. The list of participants is at **Annexure-I**.

2. The Economic Advisor (E&MDA), Department of Commerce welcomed the participants and made a presentation of the MAI Scheme giving an overview of the MAI 2021 scheme and fund position. During the EC meeting on 21.08.2024, apart from proposals for events scheduled during October 2024 to March 2025, the Committee also considered proposals for ex-post facto approval of 8 events (₹698.50 lakh), revisions in participant numbers for approved events, additional proposals for 17 events (₹1132 lakh), and certain Scheme-related clarifications. While approving some events for October 2024 to March 2025, the EC directed the Sub-Committee (SC) to re-examine the proposals relating to ex-post facto approvals, participation changes, and additional events and give Sub-Committee's recommendations. In compliance, the SC met on 26.09.2024 and submitted its recommendations, along with some additional proposals, to the EC. Accordingly, EC meeting was held on 13.03.2025 but decisions on the agenda points had been deferred **as MAI Scheme 2021 was subsumed in the Export Promotion Mission Scheme announced during the Budget announcement 2025 w.e.f. 1.4.2025 and** clarity was required regarding availability of funds.

3. In the presentation it was submitted that the EPM has since been approved by the Union Cabinet in its meeting held on 12th November, 2025 with an outlay of Rs. 4,531 crores for MAI component for the

period 2025-2026 to 2030-2031, which includes Rs. 330 crore for settlement of previous liabilities. Therefore, as soon as funds are made available at RE stage, the funds could be used for finalization of accounts of 2021-25 events. The EC noted the information placed before it.

4. After the presentation, the items on the agenda of the meeting were taken up for discussion of the Committee which were earlier recommended by Sub-committee in its meeting held on 26.09.2024. The decisions taken by the Empowered Committee on the agenda items are as under :

4.1 Agenda Item No. 1 : Guidance on entertaining Statutory Compliance Claims during the year 2025-26

4.1.1 Representations from EPCs are received seeking clarification on the following:

- a. Whether EPC can accept applications for FY 2024-25 for processing and settlement;
- b. Whether MAI reimbursement for testing charges and certification is admissible in the FY 2025-26; and
- c. Whether EPC should at all accept applications from organisations for the current financial year and if yes whether there will be relaxations in the applicable timelines.

4.1.2 **EC Decision:** EC has directed that the Statutory Compliances claims already received in E&MDA division be considered by them if product verification has been received on/before 31st March, 2025. No further statutory compliance claims may be considered under MAI henceforth by the E&MDA Division. In respect of the claims yet to be received/processed by the respective Divisions, it was directed that these claims should be presented under Statutory Compliances component of EPM through concerned Sub-Committee.

4.2 Agenda Item No. 2: Guidance regarding imposition of pro-rata cut in RBSM events in respect of lesser participation of foreign buyer: It has been informed to EC that hitherto prorata cut as per guidelines is being imposed for lesser number of participation than approved participation by EC in BSMs and in respect of RBSMs, the pro-rata cut is applied in case of lesser number of Indian Exhibitors than approved Indian Exhibitors. No pro-rata cut is being applied in case of lesser number of participation of foreign buyers approved by EC.

However, IFD suggested that rate-cut is to be imposed even in case of lesser participation of foreign buyers. As per the directions of EC in its meeting on 21/08/2024, the issue was examined in consultation with IFD and it was opined that there is ambiguity in the guidelines regarding the pro-rata cut for participants as it does not clearly specify about the pro-rata cut in the reduced foreign participants for RBSM. It was decided to take the matter to the Empowered Committee for making an enabling provision in para 7.8, if required. *Guidance of EC is solicited for finalization of RBSM accounts with/without pro-rata cut.*

4.2.1 During the discussion it was clarified that payment in respect of foreign participants is made on actual participation basis. EC observed that the foreign buyers participate from different regions and it is difficult to indicate the exact number in advance. Further when the payment is made on actual basis, there is no requirement for additional pro-rata cut as it does not entail any pre determined/conceived expenditure on foreign participants.

4.2.2 **EC Decision:** Therefore, EC has directed to continue present practice of reimbursement on actual basis subject to prescribed ceiling for foreign buyers for settling the accounts of MAI events.

4.3. Agenda Item No. 3: Proposal for ex-post-facto approval of EC for two proposals which were approved on file on 10/02/2023 amounting to Rs. 48.94 lakhs for hosting RBSM 20th Edition of Bio Asia 2023 for finalization of the Accounts for the event.

4.3.1 **Proposals for consideration of EC:** Ex-post-facto approval of the EC is solicited in respect of 2 events approved on file on 10.02.2023 amounting to Rs.48.94 Lakhs for hosting RBSM, as per **Annexure- II**.

4.3.2 **EC Decision:** EC approved the proposal contained in para 4.3 above.

4.4. **Agenda Item No. 4 :** EC gave in-principle approval for conducting Mega RBSMs with a limit up to Rs. 10 crores. Accordingly, Bharat Mobility & Bharat Tex Events were organized with a sanction of Rs. 10 crores and Rs. 8 crores respectively during year 2024.

4.4.1 **Proposals for consideration of EC:** Ex-post-facto approval of the EC is solicited in respect of Bharat Mobility & Bharat Tex Events amounting to Rs.18 Crores, as per **Annexure- III**.

4.4.2 **EC Decision:** EC approved the proposal contained in para 4.4.1

above.

4.5. Agenda Item No.5 : Ex-post-facto approval for the sanction given for a Joint Feasibility Study by RIS for exploring the trade complementarities between India and Uruguay has been approved on file for Rs. 25 lakhs.

4.5.1 FT (LAC) Division, the Administrative Division of the proposal has informed that study is not required. EC has noted the comments of FT (LAC) Division and the proposal was not considered.

4.6. Agenda Item No. 6: Approval for 7 events conducted by EPCs as recommended by the Sub-Committee for MAI assistance of ₹ 554.20 lakhs in the of FY 2024-25.

4.6.1 Sub-committee in its meeting held on 26.09.2024, considered 8 proposals and recommended 7 events for MAI assistance of Rs. 554.20 lakhs in the FY 2024-25.

4.6.2 **EC Decision:** EC approved the proposal contained in para 4.6 above, as per details given in **Annexure IV**.

4.7. Agenda Item No. 7 : Approval of the EC for **5 new proposals** (considering the request of EPCs and Territorial/Commodity Divisions for re-consideration as these are important flagship events) recommended by the sub-committee, **with an amount of ₹ 698.00 lakhs** .

4.7.1 Approval of the EC for according MAI assistance of ₹698 lakh for five new proposals, in view of the savings that have arisen due to cancellation of certain events. In case of RBSM - 10th World Ayurveda Congress (WAC), EC had earlier approved Rs. 150 lakhs for the event. Based on the request & cancellation of their another event, additional Rs. 30 lakhs was recommended for increased participation.

4.7.2 **EC Decision:** EC approved the proposal contained in para 4.7.1 above as per details given in the **Annexure- V**.

4.8. Agenda Item No. 8: A study proposal "Malaysia- India Comprehensive Economic Cooperation Agreement (MICECA)" by HCI, Kaulalampur recommended for Rs. 10 lakhs.

4.8.1 **EC Decision:** FT (ASEAN) Division, the Administrative Division of the proposal has informed that study is not required. EC has noted the comments of FT (ASEAN) Division and the proposal was not considered.

4.9. **Agenda Item No. 9 : Approval of EC for 8 proposals recommended by Sub-Committee for an amount of Rs. 504.75 Lakh** for FY 2024-25 against 17 additional events (events dated from 01.04.2024 to 30.09.2024).

4.9.1 Sub-Committee in its meeting dated 26.09.2024 after taking stock of the actual happening of the event or otherwise, recommended 8 proposals (events dated from 01.04.2024 to 30.09.2024), out of 17 additional proposed events, with MAI assistance of Rs. 504.75 lakhs.

4.9.2 **EC Decision:** EC approved the proposal contained in para 4.9 as per details given at **Annexure-VI**.

4.10 Agenda Item No. 10 : Approval of EC in respect of requests of EPCs for **change in number of participants in 13 events approved** by EC for the year 2024-25. Sub-Committee recommended the proposals. The financial implication of these changes would be saving of Rs. 356 Lakhs.

4.10.1 Commerce Secretary enquired as to why there is no change in assistance for RBSMs even though there is a change (increase/decrease) in the number of participating firms. In this regard it has been informed that funding for hosting foreign buyers will be on lump sum basis, subject to ceiling prescribed per buyer and actual expenditure on hosting them, whichever is less. Considering the availability of funds and previous sanction, the assistance is approved by the EC. The assistance covers airfare of foreign buyers, toward venue, organising, and publicity costs.

4.10.2 In respect of INDIASOFT 2025 scheduled for March 2025, ESC proposed event with 200 Indian Exhibitors and 435 Foreign Buyers. However, while sanctioning EC approved an amount of Rs 4.5 crore only consistent with assistance provided for the previous edition in 2024 (with Indian exporter - 150 and Foreign exporter -300) though the ESC had proposed to increase the number of exhibitors from 150 to 200. Therefore, ESC represented that as there has been no increase in the MAI grant to accommodate the expanded scale, they proposed to maintain the number of exhibitors at 150, as was the case in 2024 edition of the event.

4.10.3 Similarly, in case of India Electronics Expo, ESC submitted a request for DoC approval to revise the number of foreign delegates from 100 to 65 as MAI assistance for the 2025 edition was only Rs. 1 crore, consistent with the 2024 allocation in which DOC approved assistance for 66 delegates. Given that the

grant has not been increased this year, they sought a comparable adjustment. They submitted that the budget must accommodate critical costs, including airfare assistance, particularly significant for delegates from Africa and LAC regions, where Rs. 1.5 lakh per delegate applies, along with venue rental, marketing, publicity, and printing. Reducing the delegate count to 65 will ensure efficient resource allocation while upholding the event's quality and its objective of promoting the Indian electronics sector globally.

4.10.4 For the SANJEEVNI event scheduled in January 2025, SEPC originally proposed participation of 75 Indian exhibitors and 250 foreign buyers with an amount of Rs. 416 Lakhs. However, while approving the proposal, the EC sanctioned only ₹2 crore, in line with the assistance provided for the 2024 edition, which also had 75 Indian exhibitors and 250 foreign buyers.

After doing cost evaluation, SEPC requested to reduce the number of foreign buyers from 250 to 175. After considering the reduced participation and applying the region-wise funding ceilings approved by the EC, the final payable amount remains within the prescribed norms.

4.10.5 For the remaining 10 proposals, the EC-approved amounts have been revised proportionately, taking into account the reduced participation numbers and ceiling as per region wise funding norms approved by EC.

4.10.6 **EC Decision:** EC approved the proposal contained in para 4.10 above. The details of the events are given as at **Annexure VII**.

5. **Other issues: Way ahead :**

The Committee reviewed the existing MAI components and deliberated on their integration into the newly approved Export Promotion Mission (EPM). It was noted that the key elements of MAI such as support for participation in international fairs, Buyer Seller Meets, RBSM etc. would continue under EPM under Market Access Component while statutory compliance, capacity building will be in different component. It was directed that Sub-Committee of Market Access component should also consider event proposals received from EPCs on MAI portal for assistance under EPM in 2025-26 with revised sharing ratios and updated ceilings under new guidelines. Accordingly, present MAI portal should be integrated with the EPM portal.

6. The meeting ended with vote of thanks to the Chair.
