EXPORT OF RICE

Will the Minister of **COMMERCE & INDUSTRY** (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) whether India has been exporting Basmati, Parboiled Rice and Non Parboiled Rice during the last three years;
- (b) if so, the countries to which rice was exported indicating the grade of rice during the said period, year-wise;
- (c) the details of revenue earned from the export of rice during the said period, grade-wise;
- (d) whether the Government has set any targets in export of Parboiled and Raw Rice in coming years and if so, the details thereof and if not, the reasons therefor;
- (e) whether the Government has taken/proposes to take any steps to export other grades of rice besides Basmati rice and if so, the details thereof; and
- (f) the details of the measures taken by the Government to tackle the International pressure on Indian agricultural exports?

(a) to (c) India has been exporting Basmati, Parboiled Rice, Broken Rice and Non-Basmati Rice during the last three years. However, export of Broken Rice has been prohibited w.e.f. 09.09.2022 and export of Non-Basmati White Rice has been prohibited w.e.f. 20.07.2023. The details of countries to which rice was exported indicating the grade of rice during the last three years, year-wise and the details of revenue earned from export of rice during the said period, grade wise are given in **Annexure-I & Annexure-II**.

(d) The Government has not announced any product-specific targets for Parboiled and Raw Rice. The quantum of exports in a year is normally a function of multiple factors including international prices, demand, exportable, surplus, etc.

(e) Prohibition of export has only been imposed on non-basmati white rice and broken rice. Export of Basmati and parboiled non-basmati rice is continuing.

(f) The Department of Commerce provides financial assistance to promote exports, including exports of food products, through Market Access Initiatives (MAI) scheme, and Export Promotion schemes of Marine Products Export Development Authority (MPEDA), Tea Board, Coffee Board, Spices Board etc. Further, the Agricultural & Processed Food Products Export Development Authority (APEDA), a statutory organisation under the administrative control of Department of Commerce, is engaged in promoting exports of food products. APEDA has been providing assistance to the exporters of food products under various components of its Export Promotion Scheme.

A Farmer Connect Portal has also been developed for providing a platform for farmers, Farmer-Producer Organisation (FPOs) and cooperatives to interact with exporters. Buyer Seller Meets (BSMs) are organised in the clusters to provide export-market linkages. Regular interactions, through video conferences, with the Indian Missions are also organised. Continuous efforts are also made to resolve market access, trade barriers, sanitary and phytosanitary issues to enable growth in Agricultural exports from the country.

Further, though the Government has imposed prohibition on export of broken rice and non-basmati white rice to other countries, while prohibiting the export of broken rice and non-basmati white rice, the Government has taken a policy decision that export of such rice will be allowed on the basis of permission granted by the Government of India to other countries to meet their food security needs based on the request of their Governments.
