1. Review of Export Performance

The export analysis shown in Table 1 indicates that growth in 2010-2011 is over 29% having achieved exports of 4.8 billion US Dollars (figures as per DGCIS figures till February 2011 and estimates for March 2011). The plastic raw materials continued to steal the show with exports of the same comprising about 39% of the total plastics exports. The plastic raw material sector has also registered a substantial growth last year. The growth registered by value-added items (excluding raw material from the total exports) is also very encouraging at about 23% which was just 4% last year. All major sectors showed a positive growth rate. The direction of exports is shown in Table 2. Most major markets have registered a positive growth rate.

2. PARTICIPATION IN INTERNATIONAL TRADE FAIRS/EXHIBITIONS

2.1. JEC Composites Show 2010 - Paris, France - April 13-15, 2010

The Council has been consistently participating at the JEC show for the past few years. This show is one of the premier showcase for the composites sector – indeed a sector that also largely caters to hi-tech sectors like the aviation sector and the like. The council participation jointly with the FRP institute organized the Indian Pavilion.

2.2. Dar-es-salaam International Trade Fair 2010 (DITF) - Dar-es-Salaam, Tanzania - June 28-July 8, 2010

The Council concluded a successful participation at the 34th Dar es Salaam International Trade Fair 2010 (popularly known as “Saba Saba Fair”) organized by Tanzania Trade Development Authority between 28th June 2010 and 8th July 2010. The fair has established itself as one of the prime trade events in East Africa. This year the “India

Pavilion” was organized by the High Commission of India, Dar es Salaam & India’s participation was coordinated by ITPO.

2.3. Escolar 2010 - Sao Paulo, Brazil - August 30 -September 2, 2010

2.4. Feria Internacional De Bogota 2010 (Colombia Plast 2010) - Bogota, Colombia - October 4-8, 2010

Feria Internacional De Bogota, the International Fair of Bogota was held at Corferias fair ground at Bogota from 4th to 8th October 2010. India’s participation at this fair was jointly organized by PLEXCONCIL, EEPICINDIA & CAPEXIL. 2.5. JEC ASIA COMPOSITE SHOW - Singapore - October 12-14, 2010

The JEC Show Asia 2010 organized by the Journals and Exhibitions on Composites, Paris, from October 12-14, 2010 was held at the Suntec Exhibition Centre, Singapore. With the Asia-Pacific Region estimated to reach close to 50% of the world’s composite manufacturing volume of 5 million metric tons by 2015, this Annual Show added greater significance to the Indian composite sector.

With Asian markets being driven by strong economic growth resulting in greater demand for composite products, it was an important meeting place for top composites industry professionals and decision makers from the Automotive, Aerospace, Construction, Ground Mass Transportation and Marine sectors. Our members were able to renew/establish contacts with buyers and distributors in the industry, and it is estimated that new business would be generated in the near future for Composite components, products, resins and compounds. 2.7. ARABPLAST 2011 - Dubai, UAE - January 8-11, 2011

The Council participated in the ARABPLAST 2011 organised by AL Fajer Information & Services, Dubai at the Dubai International Convention & Exhibition Centre, from 8th to 11th January 2011. Arabplast leads as the region's most important & leading trade show for plastics & rubber industry. 703 exhibitors covering an area of 35000 square meters from 36 countries presented the dynamics of plastics & rubber development to approximately 18,860 visiting trade professionals mainly from Asian continent covering Middle East, Africa & the Indian sub-continent.

Bulk importers/dealers of plastic products could be accessed by personal visit. Mr V.S.Chauhan, Second Secretary, Embassy of India, Dakar visited and interacted with participating members. An exclusive brochure was brought out by the Council for the fair and distributed to the visitors. Mr.S.Vijayan, Senior Executive, represented the Council at this event.

2.10. Paperworld Middle East 2011 - Dubai, UAE - March 7-9, 2011

The Council participated in the inaugural PaperWorld Middle East 2011 Show organized by EPOC Messe Frankfurt GmbH, Dubai, held from March 07-09, 2011 at the Dubai Exhibition & Convention Centre. This was a first of its kind Show in the Region for the school, home and office products industry. H.E. Mr Abdul Rahman Saif Al Ghurair, Chairman, Dubai Chamber of Commerce and Industry, inaugurated the show on March 07, 2011.

The Middle East markets are of key significance for the writing instruments and stationery products sector. Participation in this Show enables exhibitors have better access and interaction in this growing market. While a large section of the market is driven by imports and re-exports, atleast 30% of the region's market is estimated to be manufactured locally. The exhibition attracted a great number of trade visitors from around the region including Distributors, Wholesalers and Retailers (including Supermarkets, Stationery shops, Office products suppliers and Gift shops) and was an important meeting place for industry professionals and decision makers.

The Consul General of India in Dubai, H.E. Mr Sanjay Verma, and the Consul, Mr Naresh Mehta, visited the Council's pavilion and interacted with the participating members. Mr Jaswanth Soundarapandian, Regional Director, Plexconcil Chennai, represented the Council in this event. An exclusive brochure was brought out for free distribution amongst visitors to the show.

2.11. International Home & Houseware Show - Chicago, USA - March 6-8, 2011

The International Home & Housewares Show was held from March 6-8, 2011, at McCormick Place, Chicago, USA. The Council participated at the Show for the sixth consecutive year. The Show features thousands of housewares and home goods products for every room in the house, apartment or condo, and outdoor living too. From international design to trend-setting basics, products range from kitchen electrics and small appliances to gourmet

specialty foods and cookware, from bakeware and kitchen tools to home decor, space organizers and storage systems, home healthcare and home-office to pet supplies and lawn and garden decor

The Show experienced a sold-out status for the first time in three years and rang up a 5% increase in total buyer attendance, more than 21,000 buyers, with U.S. chain retailer attendance growing at a slightly greater rate. The completely sold-out Show hosted 1951 exhibitors, with over 500 new exhibitors, reflecting a 5 percent increase in space sold over 2010.

The next International Home & Housewares Show will be held from March 11 – 13, 2012 at McCormick Place, Chicago, USA, and also feature continued co-location with The Travel Goods Show.

2.12. EXPOCOMER 2011 - March 23-26, 2011 - Panama City, Panama

The Council participated at Expocomer 2011, a multi-sector trade exhibition held from March 23 – 26, at the Atlapa Convention Center, Panama City, Panama. The event is organized by The Chamber of Commerce, Industries and Agriculture (CCIAP). With the participation of more than 630 exhibitors from 18 countries, and a strong presence of countries like China, Korea, USA and Brazil the trade show was expected to generate deals for around US\$ 130 million. The 2010 edition of the event generated business of US\$ 124 million. The exhibition is the ideal platform to use the Colon Free Trade Zone in Panama as a bridge to re-export products to the Caribbean, Central America and South America.

Members who participated at the above exhibition through the Council were M/s 3 S Corporation, Mumbai; M/s Century Commerceco, Surat; M/s Electrofocus Electricals Pvt Ltd., Thane; M/s Jainam Industries, Mumbai; M/s Labh International, Ahmedabad; M/s Labh Services P. Ltd., Ahmedabad & M/s Parekh Industries, Ahmedabad. M/s Electrofocus Electricals Pvt Ltd. was represented by the Vice Chairman Mr Rajeev Chitalia.

Our Ambassador to Panama, Mr. Vishnu Hade interacted with all the above members at the trade show. An exclusive promotional brochure in Spanish was brought out for distribution among the visitors to the show. Mr. Sanjiv R.Dewan, Regional Director represented the Council at this event.

2.13. JEC Composites Show 2010 - Paris, France - March 29-31, 2011

The Council participated at the JEC Composites 2011, held once in every calendar year and the biggest composites showcase in the world for the second time this year. The JEC Composites Show reflects the evolution of a dynamic industry that has penetrated into all application sectors. It attracted 1,065 exhibitors out of which 75% were foreign exhibitors. The show hosts a large number of regional and international pavilions which besides India include Germany (Bavaria, Saxony, and North Rhine-Westphalia), France (Aquitaine, Charente Maritime, Pays de la Loire, and Picardie), Canada, China, Czech Republic, Hungary, Great Britain, Italy, Malaysia, Morocco, the USA, and Wallonia. This Show attracted over 27,700 visitors of which 65% from abroad and 35% from France and the business generated is estimated at 589 million Euros. The visitors generally comprise of corporate decision makers. National trade organisations from all over the world, including the Asia-Pacific region which besides India included Australia, China, Japan, South Korea, Thailand and Taiwan.

Mr V G Mahajan, Deputy Director represented the Council at the show and an exclusive bi-lingual brochure (English & French) was brought out for being freely distributed amongst the visitors to the show.

3. PARTICIPATION IN INTERNATIONAL TRADE FAIRS/EXHIBITIONS

3.1 Plasto Fair 2010 – Guwahati – May 21-24, 2010

With the setting up of the Assam Gas Cracker Project by the Brahmaputra Cracker Polymer Limited (BCPL), Assam is expected to offer a lot of opportunities for downstream plastic industry. In the light of this development the PLASTO FAIR 2010 was organised at the initiative of the Department of Chemicals & Petrochemicals, Government of India; Government of Assam; Numaligarh Refinery Ltd (NRL); Oil India Ltd and BCPL. The Council participated at the fair and various export related information was disseminated. Many visitors visited Council's booth and showed interest in the Council's activities and expressed their desire to enter into the field of exports.

Other objectives (besides opportunities for setting up downstream plastic industries) included introducing and exposing all the opportunities offered by North East; building up the capacity of the local entrepreneurs to venture into plastic and allied sectors; creating public awareness for the increased usage of plastic products, providing a platform for buyer-seller interactions; inviting investment from every part of the country, facilitating joint venture collaboration with local entrepreneurs and creating awareness on latest technologies available.

Mr Anand Sharma, Hon'ble Union Minister of Commerce & Industry, inaugurated the Northeast International Plasto Fair. Mr Tarun Gogoi, Chief Minister of Assam and Mr Pradyut Bordoloi, Minister Power, Public Enterprises, Industry & Commerce, Government of Assam were also present at the inauguration function. About 122 exhibitors from the different parts of the country participated at this fair. The 4-day programme packed with exhibition, interactions and seminars have drew wide attention from all across the country, particularly from all the North Eastern States.

4. BSMs / DELEGATIONS

4.1. Delegation to France and Germany - June 28 to July 1, 2010

The delegation was aimed at furthering closer co-operation between India and France & Germany by promoting the Indian PCPIR & India Chem 2010. Executive Director (ED), Mr R P Kalyanpur participated in the above delegation. The delegation led by the Honourable Union Minister of State for Chemicals & Fertilizers Mr Srikant Jena. Other delegation members were Mrs Neel Kamal Darbari, Joint Secretary to the Government of India, Department of Chemicals & Petrochemicals; Mr Rajesh Agarwal, PS to the Honourable Minister, Mr Arvind Agarwal, Vice Chairman & MD, GIDC; Prof (Dr) S K Nayak, Director General, CIPE; Mr Rajan Kohli and Mr Manoj Mehta of FICCI; Mr P Rawat, United Phosphorous Ltd, & Mr Vikas Gadre, Tata Chemicals Ltd.

The delegation visited Moselle on 28th June where they were shown around the composite park and the design and prototyping facilities. CIPET signed an MOU with Iseetech on co-operation in higher education, research technology in plastics. Mr Petry had detailed discussions with Mrs Darbari, DG, CIPET and the ED with regard to offering free office space for 3 months which could be extended upto 9 months. It was felt that both CIPET and the Council could work together to promote development of composites by using this offer. However, Mr Petry said that the Indian side must ensure some development work in Moselle with physical presence of Indian companies. On the 29th June an investment meet was organized. The PCPIR policy and an operational PCPIR facility in Gujarat were presented by Mrs Darbari & Mr Agarwal respectively.

On 1st July in Berlin, a meeting was organized with the Federal Ministry of Economics & Technology and VCI (Federation of German Chemical Industries). Incidentally at the meeting with VCI, two important issues figured. With regard to the proposed FTA with the European union, the European side insisted that the FTA must be truly zero duties without any restrictions. This is the best offer in which both sides can benefit in their own ways. With regard to REACH, they inquired whether the Indian side was having any problems. ED mentioned that this was definitely a NTB (Non-Tariff Barrier) since the Indians are required to have a "only Representative" or their own office both of which are costly affairs. The Europeans on the other hand are at an advantage since they already have a legal entity in Europe. A factory visit was also organized to BASF plant at Shwarzheide where their Chairman of Management Board Dr Karl Heinz Tebel met the delegation.

4.2. FIBC Delegation to Japan & South Korea – December 12-18, 2010

The FIBC delegation to Japan and South Korea was primarily conceived since Japan is the single largest country (or the second largest if the European Union comprising of 27 countries is considered as a single importing identity) importing FIBCs (Flexible Intermediate Bulk Containers). South Korea is the fourth largest after Japan, Europe & USA. In both Japan & South Korea, the major supplying country is China.

A lot of effort was put in by the Council prior to the delegation visit, particularly in Japan, to organize meetings with importers of FIBCs. In South Korea, the good offices of our Embassy in Seoul proved quite useful in organizing a Buyer-Seller Meet (BSM) through the Korean Importers Association, popularly known as KOIMA, (with whom the Council had developed contacts when they visited India). As far as Japan was concerned, we were given to understand by our mission in Tokyo that they organize BSMs through organisations like JETRO or the Chambers of Commerce. These organisations regretted their ability to support our delegation when they visit Japan (it was decided that the delegation would visit Tokyo and Osaka).

In case of Japan, the Council therefore decided that it will compile a database from various sources (including a small list furnished by our Embassy) and go about contacting them telephonically and through emails. The Council was able to generate enough response and arrange meetings both in Tokyo and Osaka for the proposed visit.

The delegation was led by the Chairman Mr Manoj Agarwal and accompanied by the Executive Director Mr R P Kalyanpur. The other delegation members were Mr Ravish Kamath, Big Bags India Pvt. Ltd, Bangalore; Mr S Ramakrishnan, Buildmet Fibres Pvt. Ltd, Bangalore; Mr R Panchapakesan, Cigfil Limited, Bangalore; Mr Samresh Choudhary, Commercial Syn-Bags Ltd, Indore; Mr Makrand Appalwar, EMMBI Polyarns Ltd, Mumbai; Mr G Ramraj, Jumbo Bag Ltd, Chennai & Mr Joseph Francis, Executive Director & CEO, Rishi FIBC Solutions Pvt. Ltd, Ranu, District Baroda.

In Seoul - the BSM was organized at the KOIMA premises on the 13th December 2010. There was a inaugural function before the BSM when Mr James Lee, Manager -International Cooperation Office, KOIMA welcomed the participants. Chairman of the Council made a presentation on the Council, the Indian scenario and the Indian FIBC industry. Mr Makrand Appalwar of Emmbi Polyarns Ltd, Mumbai presented a technical paper on various aspects of the FIBC industry. Firms dealing in FIBCs visited the BSM and interacted with the delegates. It is understood

that there are barely about 25 importers of FIBCs located in Seoul and surrounding areas and a total of about 50 importers of this item in South Korea. The Embassy also fixed up meetings with a couple of importers in Busan (about four hours by train from Seoul) and three members proceeded to Busan to meet them on 14th December 2010. Our Embassy provided excellent support during our visit and the Second Secretary Mr Satish Sharma also actively participated in the BSM and interacted with the participants. Later in the day the Chairman and the Executive Director met Mr Jeeva Sagar, Minister in our Embassy in Seoul.

In Japan, the delegation visited Tokyo on the 15th & 16th December and Osaka on the 17th December. The meetings in both the places were very fruitful. One signal that was very clear was that the Japanese were seriously considering India as an alternate source of supply possibly due to certain problems faced by them both in China and Vietnam. At the same time, based on the many questions being posed to the Indian side, it appeared that the Japanese will be doing a lot of spade work before they decide on entering into business contracts with the Indian manufacturers.

The delegation visit was certainly very useful and it is hoped that the Indian FIBC industry will, in the near future, successfully tap the potential and gradually get a good market share.

4.3. Composite Delegation/BSMs to/in Panama, El Salvador & Mexico – March 21 to April 3, 2011

The Council concluded a successful visit to Panama City, Panama; San Salvador, El Salvador & Mexico City, Mexico. This event coincided with the renowned EXPOCOMER 2011, an annual event, in Panama City which was held from 23rd to 26th March 2011. In Panama City, the Council had identified buyers, particularly in the Colon Free Trade Zone, and set up meetings with our participating members at the EXPOCOMER. The BSM in San Salvador was organized at the Hilton Hotel on 28th March 2011 where the services of the Chamber of Commerce were utilized. The Chamber made a match making exercise and invited appropriate firms for the BSM. The BSM in Mexico was held on 31st March 2011 at the Radisson Hotel. ANIERM (the apex body representing exporters and importers from Mexico) arranged the meetings. Our Embassy in Mexico City extended excellent support and co-operation. The BSMs were well organized and attended by the target audience. The participating members were M/s Electrofocus Electricals Pvt Ltd., Thane (represented by Mr. Rajeev Chitalia the Vice Chairman of the Council); M/s 3S Corporation, Mumbai; M/s Century Commerceco, Surat; M/s Jainam Industries, Mumbai; M/s Labh International, Ahmedabad; M/s Labh Services Pvt. Ltd., Ahmedabad and M/s Parekh Industries, Ahmedabad. Council was represented by Mr. R P Kalyanpur, Executive Director

5. SEMINARS/WORKSHOPS

5.1. Export Seminar - Hotel Metropolitan, New Delhi - 27th May, 2010

The above Export Seminar was held with the objective of informing the exporters from the MSME Sector about the **Financial Assistance for exports under the MDA / MAI Scheme of the Department of Commerce, as also to create awareness about some of the trade finance tools available for exports, such as factoring.** Mr. Manoj Agarwal, Chairman delivered the Welcome Address. This was followed by a presentation on Factoring Service for Exports by Mr. Ashutosh Goel, Vice President, SBI Global Factors Ltd. (Subsidiary of State Bank of India), New Delhi. Mr. Goel highlighted the various advantages of factoring for exporters.

Mr. S.R. Dewan, Regional Director also gave a presentation on Financial Assistance for Exports exporters under the MDA/MAI Scheme of the Department of Commerce and Export Promotion Activities of the Council planned for the current F.Y. 2010-11. The seminar concluded with an Interactive Session with the participants.

5.2. Seminar on "Trade Finance and Funding Options & Currency Futures as a new hedging tool for the MSME sector" - Chennai – August 6, 2010

The Council organized an export promotion seminar on "Trade Finance and Funding Options" for the MSME sector on Friday 6th August 2010 at the Park Hotel, Chennai. Council Chairman, Mr Manoj Agarwal, delivered the welcome address. This seminar was organized to highlight various options available, particularly for MSME exporters, to surmount high transactions cost involved in international business and to disseminate information on new funding options particularly for the MSME sector, through a presentation on "Trade Finance and funding options for the MSME Sector" as this will help exporter members avail financial resources at attractive cost to compete better in international markets. This presentation was made by Mr G. Harikrishnan, Associate Vice President and Mr Muffadal Bhagat, Associate Vice President, HSBC Bank, Chennai. With the global economic situation continuing to be challenging, particularly with the advanced markets in Europe and North America engulfed with inherent currency fluctuation risks, a presentation on "Currency Futures as a new hedging tool for the MSME Sector" was made by Mr M M Aravind, Assistant Vice President MCX Stock Exchange Ltd., Chennai to address members concerns on managing forex risks and strengthen their resolve and confidence to continue their foray in the highly competitive international marketplace.

5.3. Seminar on "Doing Business with Latin American countries" – Mumbai – August 23, 2010

The above seminar was jointly done with EEPIC INDIA primarily to portray the export opportunities available in Latin American countries with a focus on Colombia. This was primarily to motivate the members to participate in

Colombia Plast / Feira Internacional De Colombia. H E the Ambassador of Colombia to India Mr Juan Alfredo Pinto and H E the Consul General of Argentina in Mumbai participated and addressed the audience..

5.4. Seminar on Annual Supplement (2010-11) to the Foreign Trade Policy 2009-14 - September 9, 2010

A seminar on Annual Supplement (2010-11) to the Foreign Trade Policy 2009-14 was organised by PLEXCONCIL jointly with CAPEXIL on 9th September 2010 at the Bengal Club, Kolkata. The main objective of the seminar was to highlight the major changes announced by the Department of Commerce, Government of India on 23rd August 2010. Mr Sudhakar Kasture, Director, Exim Institute made a detailed presentation on the Annual Supplement to the Foreign Trade Policy 2009-14. He also highlighted issues listed by Task Force with respect to Foreign Trade Policy. The seminar concluded with a very useful and interactive Question and Answer Session.

5.5. Annual General Meeting & Export Seminar on Forex Risk Management using Currency Features, Export Credit and Working Capital Facilities – Mumbai - September 15, 2010

The AGM was held as per requirements which, was followed by the Emergent Meeting of the Committee of Administration. The post lunch session was a seminar on Forex Risk Management and Export Credit/Working Capital Facilities. Vice Chairman Mr Rajeev Chitalia delivered the welcome address. Mr Pulak Basak of MCX made a presentation on Forex Risk Managements and the products available to manage the risks. Mr Javed Iqbal and Mr Priyan Subramanian of HSBC made presentations on Export Credit and Working Capital Facilities.

5.6. Export Promotion Seminar – Kolkata – January 18, 2011

The Council organized an Export Promotion Seminar on Tuesday, 18th January 2011 at Hotel Hyatt Regency, Kolkata. Mr A K Basak, Regional Chairman (Eastern Region) welcomed the participants. Mr Manoj Agarwal, Chairman addressed the gathering. Government of India has approved the proposal of West Bengal Government to set up WBPCPIR (West Bengal Petroleum, Chemicals and Petrochemical Investment Region) at Haldia region and under this project a Plastic Park will be set up at Nayachar.

In this context, Mr Sanjay Mehan, Senior General Manager, M/s PCR Chemicals Pvt Ltd, (a joint venture company between West Bengal Industrial Development Corporation and New Kolkata International Development Pvt Ltd) made a detail presentation on the proposed Plastic Park. This was followed by a presentation on 'Various Schemes of ECGC to cover credit risks in exports' by Mrs Arpita Sen, Sr Manager, ECGC. Mr Arindam Saha, Vice President, MCX-SX made a presentation on 'Currency Derivatives'. The seminar concluded with an interactive session with the participants.

5.7. Export Awareness Seminar – Rajkot - 4th March, 2011

The Export Awareness Seminar was held at Rajkot, with the objective of informing the exporters from the MSME Sector about the Financial Assistance for exports under the MDA / MAI Scheme of the Ministry of Commerce & Industry, as also to create awareness about some of the trade finance tools available for exports.

The welcome speech in the local language Gujarati was given by Mr Rajiv Chitalia, Vice Chairman, Plexconcil. Mr R P Kalyanpur, Executive Director, Plexconcil gave a presentation on Export Potential of Plastic Items, Followed by presentation by Mr V G Mahajan, Deputy Director on Role of Plexconcil in Export Promotion / MDA – MAI guidelines.

Presentations were also made by Mr Nipesh Thakkar, Branch Manager, ECGC, Rajkot on role of ECGC on Export Promotion and by Mr M B Pahlajani, Chief Manager, State Bank Of India, Rajkot on Foreign Currency Loans – Term Finance. Mr Vasant Jivani, President, Saurashtra Plastics Manufacturers Association, Rajkot and Mr Savji Parsana, President of Rajkot Kitchenware Manufacturers Association, Rajkot were guests invited by the Council.

The seminar concluded with an Interactive Session with the participants. Mr Dhirajlal Vagadia, Partner of M/s Apex Irrigation, Rajkot concluded the seminar with vote of thanks to the participants in Gujarathi. The seminar was well attended. About 40 non-members attended the seminar.

1 SIGNIFICANT ACCOUNTING POLICIES

a) ACCOUNTING CONCEPT:

The financial statements are prepared on the basis of historical cost convention, in accordance with applicable accounting standards and on the basis of a going concern assumption.

All income and expenses to the extent considered receivable and payable, respectively with reasonable certainty are accounted for on accrual basis, unless otherwise stated.

Membership subscription, which remains unpaid as at the close of the year is not accounted for except the amount actually received out of such unpaid subscriptions close to the adoption of financial statements by the Committee of Administration.

Entrance Fees receipts are credited to Corpus and Capital Fund.

b) FIXED ASSETS:

Fixed Assets are stated at cost of acquisition less accumulated depreciation.

c) DEPRECIATION:

Depreciation on Fixed Assets is provided on written down value method at the rates and in the manner prescribed in Schedule XIV to the Companies Act, 1956.

In respect of additions to fixed assets during the year, depreciation is considered on pro-rata basis.

Assets costing ` 5, 000 or less each are fully provided in the year of addition.

d) REVENUE RECOGNITION:

I. The cost of Publications of the Council is charged to the Income and Expenditure Account in the year of incurrence of such expenses. However, the Income in respect of the same is taken into account as and when their sales are affected. The movement of Publications is controlled under the overall supervision of the Executive Director.

II. Individual items of Prepaid expenses over `5,000 only are accounted for.

e) GOVERNMENT GRANT:

I. Grants received from Government in respect of coded activities is credited to Income and Expenditure Account on the bases of fair estimate for the same as provided by the management that is based on the applicable criteria prescribed by the Government for the same.

II. Grants received for acquiring the specific fixed assets, are reduced there from and such assets are stated net of such grants and or at a nominal value as the case may be.

III. Grant under MDA initiative is received from Ministry of Commerce is based on the claims from the exporters as per the guidelines prescribed on this behalf and to be distributed as such to the claimant exporters. Disbursal that remains unpaid to individual exporters till the date of financial statement is reflected as current liability.

IV. Grant received for the specific studies approved by the Government targeted to achieve specific objectives and activities thereof, is undertaken by the council till the time it is utilized is carried forward as liability. In amount spent on the projects as per the guidelines includes appropriate allocation of the administrative cost incurred by the council on the study.

f) RETIREMENT BENEFITS:

I. Council's Contribution to Employee's Provident Fund maintained under the Employee's Provident Fund Scheme run by the Government is charged to Income and Expenditure Account.

- II. The Employees' gratuity liability is funded with the Life Insurance Corporation of India under Group Gratuity Scheme. Hitherto, Council was accounting for the minimum premium payments towards gratuity liability. There is substantial upward change in the Council's cumulative gratuity liability and Council has provided for incremental liability amounting to Rs 32,32,964/- through income and expenditure account.
- III. Leave Encashment Benefits as applicable to permanent employees are provided for on accrual basis as at the year-end as per the Council's rules.
- g) TRANSACTIONS IN FOREIGN CURRENCY:**
Transactions in Foreign Currency are recorded at the rates of exchange in force at the time of occurrence of the transactions. The difference arising out of foreign currency fluctuations is accounted as a part of revenue or expenditure as the case may be as has occurred during the course of the year.
- Current Assets and Current Liabilities in Foreign Currency at the year-end are stated at the rate of exchange in force as on that date and the resultant Gain/(Loss) is recognized in the Income and Expenditure Account.

h) PROVISION FOR TAXATION

The company is licensed to pursue charitable objects and is registered under section 25 of Company's Act, 1956 and registered under section 12A of Income Tax Act, 1961 and as such income is not taxable in view of exemption under section 11 and 12 of Income Tax Act, 1961.

2 NOTES ON ACCOUNTS:

- 2.1 Contingent Liability not provided for:
- a) In respect of interest / penalty for non-compliance of certain fiscal statutes, amount unascertainable.
 - b) The arrears calculated on the basis of 6th pay commission recommendations to the ex-employee or employee whose service are terminated amounting to `3,73,920/-.
 - c) The council is registered under Service Tax law w.e.f.1.4.2010 and discharging its obligations, however the issues raised by the service tax authorities as to applicability of Service Tax Liabilities for prior year starting from 1.6.2007 till the date of registration i.e.1.4.2010. The matter is being represented before appropriate authorities and exact liability, if any, is not ascertainable at this stage.
- 2.2 The expenses in respect of Code-activities are subject to sanction/confirmation of the Government of India and Grant-in-aid received from the Ministry of Commerce is subject to adjustments in the light of Government Audit, non/partial fulfillment of certain conditions for eligibility of such Grant-in-aid, clarifications by the Council and final decision of the Ministry.
- 2.3 There are no dues which are overdue to Small Scale and / or Ancillary Industrial Suppliers as at the year-end.
- 2.4 As per the consistent accounting policy followed, the Council has not accounted for the Stock of Publications / CD's as the said publications / CD's are generally meant for distribution at the Exhibitions/ Seminars, and those remaining unsold for a period of two years or more have negligible realizable value.
- 2.5 Fixed Assets being equipment, which was acquired from the financial support from the Government, retired from active use pending formal approval from the Govt. of India for write-off is shown as provision for diminution in the value of fixed assets amounting to Rs 106,240/-.
- 2.6 Pursuant to the approval by the Finance Division of the Department of Commerce, Government of India for grant of Marketing Development Assistance (MDA) to individual exporters under certain eligible schemes, the Council has received from the Ministry of Commerce `100,00,000/- (Previous Year ` 96,60,000/-) and `55,43,027/- (Previous Year Rs 34,02,339/) is reimbursed to the members during the year. Total liabilities to be reimbursed to members as on 31st March, 2011 amounting to ` 44,60,686/- (Previous Year ` 62,61,374/-) is being disclosed as 'Amount due to Members' under Current Liabilities.
