This event is being organized with financial support from the Department of Commerce, Government of India, **under the Market Access Initiative (MAI) Scheme**. The rates are subsidized in comparison with the normal rates offered by the Fair Authorities.

PLAST EURASIA ISTANBUL 2019, organized by the Tuyap Fairs and Exhibitions Organization Inc., is the most important platform for global marketers to enter the Turkish and Eurasian markets, and brings together leading industry professionals and purchase decision makers seeking a wide range of Plastic Raw Materials, Chemicals, Composite Finished and Semi-finished Products, Moulds as well as Recycling and Plastic Machinery, among others. **Plastic Raw Material, Masterbatches, Additives, Compounds, Fillers, Auxiliaries etc, Plastic Packaging, Plastic Construction Materials, Moulds, Recycling and Plastic Machinery, Finished and Semi-Finished products etc** will have good potential in the Eurasian markets. The potential for plastic items in this region is tremendous, and this event will give an excellent platform to tap this potential.

Turkey is amongst the top 10 destinations for plastics products from India. In 2018-19, India exported plastics products worth ~ US\$ 280 million to Turkey.

- During 2017-18, Turkey imported plastics worth US\$ 16.23 billion from the World. However, India's share in the overall plastics import by Turkey was just 2.0%.
- The European Union is a huge market for India. during 2017-18, the European Union imported plastics worth US\$ 346 billion from the World.

The 2018 edition of the **Plast Eurasia Istanbul** Show saw over 1,094 exhibitors from 44 countries with national pavilions from China, India, Iran, & Taiwan. Over 51,684 industry professionals from 103 countries visited the fair. For more details you may visit <http://plasteurasia.com/en/>

The reimbursement amount is only indicative which may vary on basis of number of participants and grants released by the government for the event*

***Air Fare:** In addition to the above "Economy Class Air fare will be reimbursed to the eligible participating members of the PLEXCONCIL, as per MDA guidelines (strictly on first-cum-first-served basis maximum upto 25 Members) as per previous MDA scheme & it will be provided subject to Government's approval and only after receipt of funds from the government.*

Payment schedule: 50% non-refundable payment along with application and Balance payment of 50% must be paid before 30th September 2019.

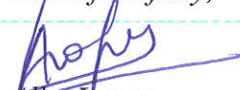
***Application:** Interested members are requested to confirm their participation by sending attached application form duly completed along with 50% non-refundable advance payment.*
