Sub : Regarding the portal for clearance of pending Advance/EPCG/DFIA/EOU Authorization files by JNCH

We wish to inform you that the O/o Commissioner of Customs (NS-II), JNCH has recently issued Public Notices no. 05/2019 dated 09.01.2019 (<http://jawaharcustoms.gov.in/pdf/PN-2019/05-2019%20Public%20%20Notice.pdf>) regarding the portal for clearance of pending Advance/EPCG/DFIA/EOU Authorization files.

As per the said public notice there are total 14870 No' of of Advance Authorizations, 8217 No's of EPCG Authorizations and 675 No's of DFIA Authorizations issued from various offices of Joint DGFT & registered at Jawaharlal Nehru Customs House, Nhava Sheva, Zone - II, which are pending due to non - receipt of Export Obligation Discharge Certificate/Redemption letter issued by Joint DGFT.

In view of the above, it is requested to submit copies of Redemption Certificate/EODC of all such cases without delay for Bond cancellation as well as for smooth clearance of live consignments.

It is being informed that licence holders can submit copies of Redemption Certificate/ EODC and other related documents during the special drive which shall be organized at Room No. 702, 7th floor, C - Wing, Jawaharlal Nehru Custom House, Nhava Sheva, Tal-Uran, Dist. -Raigad, Maharashtra -400 707 from 21.01.2019 to 01.02.2019 for cancellation of pending Bond/ BG. They can also submit the same during any other working day in the concerned section also.

For cancellation of Bond/BG submitted against EPCG Authorizations documents required are as under:

- Original EODC/Redemption Letter
- ANF 5B duly certified by Chartered Accountant.
- Copy of Installation Certificate issued by Chartered Engineer/Central Excise/GST authorities.
- Original EPC
G Licence.
- Copy of S/Bs (ARE - 1 in case deemed exports).
- Bank Realization Certificate.
- In case third party export (documents as per FTP 2015 – 20).
- Other relevant documents submitted to DGFT.

For cancellation of Bond/BG submitted against Advance Authorizations documents required are as under:

- a) Original EODC/Redemption Letter.
- b) Original Advance Licence.
- c) No Bond Certificate,
- d) Copy(s) of Bill(s) of Entry,
- e) Copy(s) of Shipping Bill(s),
- f) Other relevant documents submitted to DGFT.

For cancellation of Bond/BG submitted against DFIA Authorizations documents required are as under:

- a) Original EODC/Redemption Letter.
- b) Original Licence.
- c) Cenvat Declaration certified by Chartered Accountant or Central Excise.
- d) Other relevant documents submitted to DGFT.
- e) In case 100% EOU, submit RWC.

It is also being informed that in the cases where export obligation has been fulfilled, Licence holders are required to submit evidence of fulfilment of export obligation or proof of documents submitted to DGFT for issuance of EODC so that action under section 142 of Customs Act, 1962 may not be initiated.

Relevant Member-exporters exporting/ importing through JNPT may take note of the above PN's and do the needful wherever necessary.
