This has reference to communication dated 27th March, 2018 received from Department of Commerce (FT SA) Division regarding 3rd meeting of Joint Working Group (JWG) between India and Iran held on 13th – 14th February 2018 at Tehran, Iran

We wish to inform you during the said meeting both sides agreed to encourage private sector investments in the other country for strengthening bilateral commercial and investment ties. The Iranian side proposed cooperation in attracting foreign investment in Chabahar Free Zone for making Chabahar as a regional transportation hub using the expertise and experience of India and capability of Indian public and private sectors in Small and Medium Enterprises (SMEs). The Iranian side further suggested that since Chabahar enjoys the benefit of low electricity tariffs, invited Indian energy intensive industries including petrochemical, steel, aluminum to invest in this free zone.
