We request you to kindly go through the election rules and the note mentioned in the nomination form while filling the nomination form especially with regard to the eligibility of the candidate to contest for the various posts.

In case if there is no valid nomination received for reserved categories that seat shall be deemed to be unreserved.

A member can file nomination for only one post.

The voting for the election to the Panel Chairman would be made by the respective product group members. The Proposer and Secunder shall also be from the same Panel.

The voting for the election to the Regional Chairman would be made by the members of their respective region. The Proposer and Secunder shall also be from the same region.

The voting for the election of COA member of the respective region shall be made by the members of the concern region.

The COA member who would retire at the ensuing Annual General Meeting are entitled to contest for the election.

Only the authorized representative, whose name is mentioned in the RCMC with the Council shall be eligible to contest, propose or second at the Election.

However, in the absence / non-availability / unwillingness of such authorized representative, any person who is duly authorized by the existing partners / directors / managing committee member etc., as the case may be, shall be eligible to contest for the Election provided that the name of such authorized person as partner / director / managing committee member / trustee etc. is registered with Director General of Foreign Trade (DGFT).

The duly completed nomination form can be sent to Council's Head Office on or before 21<sup>st</sup> October 2020 by 5 p.m by any of the following mode:

- (a) By email at the official Email office@plexconcil.org of the Council
  - (b) By depositing the nomination in sealed cover addressed to "The Election Committee" in the election nomination box kept at the Head Office of the Council.
- OR
- (c) By post in a sealed envelope addressed to "The Election Committee" and sent to the Council's Head Office.

The nominations received by 21<sup>st</sup> October, 2020 would be scrutinized by the returning officer nominated by the Government of India on 23<sup>rd</sup> October, 2020 subject to the availability of returning officer.

Nomination can be withdrawn by the candidate by giving a letter signed by him/her/them latest by 26<sup>th</sup> October, 2020. Withdrawal of nominations by electronic means such as emails will be considered or accepted by the Election Committee. Such a withdrawal shall be final and no subsequent request, for rescinding such withdrawal shall be entertained by the Election Committee.

The final list of candidates for election would be published on 27<sup>th</sup> October, 2020. The same would be uploaded on Council's website and on the notice board of the Council at its Head Office.

The final list of the elected candidates would be declared on 5<sup>th</sup> November 2020 which would be uploaded on Council's website and on the notice board of the Council at its Head Office.

It is to be noted that all the nomination form duly filled should accompany the declaration as per Annexure 5 and Chartered Accountants' Certificate as per Annexure 6 without which the application will be considered incomplete and cannot be treated as valid nomination.

The decision of the Election Committee in this regard would be final and binding on the members.
