Subject : (1) Final Finding - Anti-dumping investigations on the imports of "Polyethylene Terephthalate (PET Resin)" originating in or exported from China PR.
(2) List of Anti-dumping duties expired in 2020

We would like to inform you that Directorate General of Trade Remedies (DGTR) has issued Final Findings (OI CASE No: 17/2019) dated 28th December, 2020 regarding Anti-dumping investigations on the imports of "Polyethylene Terephthalate (PET Resin)" originating in or exported from China PR.

THE CONCLUSION & RECOMMENDATIONS BY DGTR IS GIVEN BELOW

The Authority notes that the investigation was initiated and notified to all interested parties and adequate opportunity was given to the domestic industry, Embassies of the subject countries, exporters, importers and other interested parties to provide positive information on the aspect of dumping, injury and causal link. Having initiated and conducted the investigation into dumping, injury and causal link in terms of the provisions laid down under the Rules, the Authority is of the view that imposition of Anti-Dumping Duty is required to offset dumping the injury. Therefore, Authority recommends imposition of anti-dumping duty on imports of subject goods from the subject country.

In terms of provision contained in Rule 4(d) & Rule 17(1) (b) of the Rules, the Authority recommends imposition of anti-dumping duty equal to the lesser of margin of dumping and the margin of injury so as to remove the injury to the domestic industry Accordingly, definitive anti-dumping duty equal to the amount mentioned in Column 7 of the duty table below is recommended to be imposed for five (5) years from the date of the Notification to be issued by the Central Government, on all imports of goods described at Column 3 of the duty table, originating in or exported from China PR.
