As advised by the Department of Commerce, Govt. of India, we are sharing herewith a list of products (details available at for which BIS is the certification agency. We have been informed that Non-Tariff-Barriers(NTBs) of these products will be taken up in Bilateral Cooperation Agreement (form of MRA) by BIS with its counterpart agencies in other countries to ensure these products don't face non-tariff barriers of the nature of TBT.

Mutual Recognition Agreements (MRA) : A mutual recognition agreement (MRA) is an international agreement by which two or more countries agree to recognize one another's conformity assessments results (for example certifications or test results). A mutual recognition arrangement is an international arrangement based on such an agreement.
