As we all are aware that the EU is at the forefront of international efforts to fight climate change. The European Green Deal sets out a clear path towards realising the EU's ambitious target of a 55% reduction in carbon emissions compared to 1990 levels by 2030, and to become a climate-neutral continent by 2050. As part of these efforts, the Carbon Border Adjustment Mechanism (CBAM) is a climate measure that should prevent the risk of carbon leakage and support the EU's increased ambition on climate mitigation, while ensuring WTO compatibility.

To spread awareness about proposed EU's CBAM legislation, we are pleased to inform you that **The Plastic Export Promotion Council (PLEXCONCIL) is organizing a Webinar on Introduction to European Union's proposed Carbon Border Adjustment Mechanism (CBAM) Legislation and its impact on Plastic Exports from India** on 14th October, 2022 (Friday) from 04.00pm- 05.30pm.

- A **deep dive into CBAM**, exploring the key features of the legislation, including how economic operators will comply with the detailed reporting obligations that apply as soon as 1 January 2023
- **CBAM's consistency with the EU's international obligations**, including under the World Trade Organization and the Paris Agreement.
- **Strategic considerations** for Plastic Exporters with respect to compliance with CBAM.
