Participation Benefits:

The event is subject to approval by the Ministry of Commerce & Industry for Market Access Initiative (MAI) Scheme. Upon approval, eligibility of participants for stall subsidy and airfare reimbursement shall be subject to the revised MAI guidelines.

Exhibitors are eligible to avail stall subsidy under MAI Scheme for a maximum of three participations (including past cases) in a particular event. Exhibitors will be separately informed about the quantum of subsidy available once the same is approved.

Eligible companies will be entitled for reimbursement of economy class airfare upon submission of requisite documents post-event. Only one person per company, i.e; only the Director/ Proprietor/ Partner/ Officer at senior managerial position will be eligible for airfare reimbursement.

Travel Advisory:

At present, there are no travel restrictions from India to Germany for fully vaccinated Indians. With regards to COVID-19 regulations, it may be noted that Indian passengers will have to adhere to the travel guidelines of the destination country at the time of travel for the exhibition.

Terms & Conditions for Participation:

Participation in the event will be with complete adherence to the terms and conditions as per the application form and revised MAI guidelines.

The participation charges are non-refundable in any circumstance.

The event organizer reserves the right to reschedule or cancel the event.
