The Secretariat has, as required by the Agreement establishing the Trade Policy Review Mechanism (Annex 3 of the Marrakesh Agreement Establishing the World Trade Organization), sought clarification from China on its trade policies and practices.

China regards the restoration of the Appellate Body as the top priority and made significant contributions to achieving consensus on having a fully well-functioning dispute settlement system accessible to all Members by 2024 in the MC12 outcome document. China has been deeply engaged throughout the informal process of dispute settlement mechanism reform, putting forward China's proposals and working with all Members to push for the Ministerial Decision on the dispute settlement reform at MC13. In addition, China, along with other Members, has established

Multi-Party Interim Appeal Arbitration Arrangement (MPIA) as an interim measure to safeguard Members' rights to appeal.
