**Subject : Regarding INDIA-USA Bilateral Trade Agreement**

We are in receipt of communication from Department of Chemicals & Petrochemicals, New Delhi seeking members inputs relating to Plastic products for INDIA-USA Bilateral Trade Agreement.

It is informed by the Department that the Joint Statement issued between India and USA leaders during their meeting on 13th February, 2025 in Washington, a vision has been set for both the countries to increase the bilateral trade to \$500 billion by 2030 and negotiate a multi-sector Bilateral Trade Agreement (BTA). In view of it, the above subject, it is requested to kindly provide inputs relating to Plastic / Petrochemicals on the following:

1. Identification of India's offensive and defensive asks with the US.
2. List of tariff lines where India can offer concessions (e.g. tariff elimination/reduction, TRQ, MIP, etc.) and provide market access to the US.
3. List of non-tariff barriers (NTBs) faced by India in the US market, as well as the challenges faced by US exporters in the Indian market.
4. Identification of other trade challenges faced by India, including:
  - i. Trafficking Victims Protection Reauthorization Act (TVPRA) and its impact on Indian exports.
  - ii. Countervailing duties imposed by the US on Indian products.
  - iii. Anti-dumping duties
