Subject: Request for inputs on India's market access offer to Peru

This is with regards to the trailing circular seeking member inputs on India's market access offer to Peru for 111 PLEXCONCIL products at 8-digit HS codes. Since we have not received any input from members, we have decided to propose the following market access commitment.

- For 38 raw materials from HS Code 39041020 to HS Code 39140090, we have proposed **Elimination of Tariff with Immediate Effect** to reduce imported cost of raw materials for local industry
- For 71 value added products from HS 39161010 to HS 39269071, we have suggested **Exclusion from any tariff reduction commitment** to discourage imports and promote Make in India and exports

HS Code wise proposal is attached herewith for your kind reference.

We request you to write back to us in case you have any concerns or alternative suggestions with regards to these proposals so that we can incorporate them accordingly.

Subject: Request for inputs on India's market access offer to Peru

We wish to inform you that the Department of Chemicals & Petrochemicals has requested inputs from the industry on market access commitment that can be offered to Peru under the ongoing FTA negotiation for 111 PLEXCONCIL products at 8-digit HS codes (see the attached list).

In this regard, we request you to indicate your suggested modality of tariff reduction/elimination commitment from the following five options:

Categorization of Modalities	
Modality	Description of Modality
EIF	Immediate tariff elimination on effective duty from the date of entry into force of this agreement.
E5/E10	Phased elimination on effective duty for the period 5 years or 10 years from the date of entry into force of this agreement.
R0 by "%" "	Immediate tariff reduction by recommended "%" on effective duty from the date of entry into force of this agreement.
R5/R10 by "%" "	Phased reduction by recommended % on effective duty for the period of 5 years or 10 years from the date of entry into force of this agreement
EL	Exclusion List
