Subject: Invitation of Member Inputs on new HS Code Suggestions

As you are aware, the Department of Chemicals & Petrochemicals has invited suggestions from the industry for creating new **HS Classification tariff lines or re-classification in some existing tariff line** of goods imported under “Others” category of Chapter 39.

One of our members have suggested creation of new HS Code for the Product category: **‘Cosmetic Bottles, Pharma Bottles, Jars for different food items and chocolates, Edible oil bottles etc...’** Therefore, we have decided to suggest creation of new **HS Code: 39233020** for this product.

Since we have not received any suggestions for the “**Others**” category under **HS Code 3926**, we decided to propose the creation of the following **nine new HS Codes** based on our study of HS Classification System in USA and Taiwan that have a well-defined product classification under this Code:
