Subject: Request for data for review of Remission of Duties and Taxes on exported Products (RoDTEP) & Remission of State and Central taxes and levies (RoSCTL) rates.

This has reference to our earlier circular ref. **Plexh/Cir/600** dated **10/10/2025** wherein Government of India vide Order F. No. 602/5/2025 dated 01.10.2025 constituted a Committee for updating the recommended ceiling rates schedules under the RoDTEP and RoSCTL Schemes. In this regard, a draft proforma was circulated for obtaining data for the review exercise, for which suggestions/comments were solicited. Stakeholder consultation, on the draft format and general rates review exercise, was held on 30th October, 2025.

Based on the inputs received, the Department has finalized format (download the format from here - https://membership.plasticsepc.org/emails_images/20251104051842.xlsx)

While providing the above data (period 01.04.2024 to 31.03.2025), care should be taken regarding the following aspects: -

- a) Data provided should be certified by the manufacturer and its Chartered Accountant/ Cost Accountant.
- b) The data should be supported by copies of representative documents, such as tax invoices of inputs used, shipping bills of export product, State Govt, notifications regarding taxes/levies like electricity duty, mandi tax etc.
- c) In this format, it may be noted that:
 - i) Part-1 is general information pertaining to the manufacturing unit.

- ii) Information in Part-2 pertains to items covered by the RODTEP Scheme.
- iii) Information in Part-3 is to be furnished for export goods falling under RoSCTL scheme.

You are requested to furnish the data by **19.11.2025** to the undersigned at bharti@plexconcil.org ; shilpa@plexconcil.org . A copy of data submitted should also be emailed in MS Excel format.

Subject: Regarding constitution of RoDTEP Committee 2025 & Request for Comments on Data Format for Review of Remission of Duties and Taxes on Exported Products (RoDTEP) and Rebate of State and Central Taxes and Levies (RoSCTL) Rates

The Government of India has constituted the **RoDTEP Committee 2025** to review and update the notified remission rates under the **Remission of Duties and Taxes on Exported Products (RoDTEP)** scheme and the **Rebate of State and Central Taxes and Levies (RoSCTL)** scheme.

Terms of Reference

The Committee's key functions include:

- Interacting with Ministries, Export Promotion Councils, Commodity Boards, Trade Bodies, and other stakeholders to gather views on RoDTEP and RoSCTL rates for exports under Domestic Tariff Area (DTA), Export Oriented Units (EOU), Special Economic Zones (SEZ), and Advance Authorization (AA) schemes.
- To work out the modalities for calculation of duties/ taxes/ levies at the Central, State and Local level, borne on the exported product, including prior stage cumulative indirect taxes on goods and services used in the production of exported product and such indirect duties/

taxes/ levies in respect of distribution of exported product and recommend in their report the ceiling rates under RoSCTL and RoDTEP schemes for DTA, AA, EOU and SEZ exports. The Committee may take into consideration the incidence of such duties/ taxes/levies on DTA, AA, EOU and SEZ exports and other relevant factors as deemed fit.

- Recommending ceiling rates under the RoDTEP and RoSCTL schemes for various export categories.
- Providing supplementary reports addressing issues arising after revised rate notifications.

(Note: Supplementary report, if required, may be submitted within six weeks of notification of the revised rates under the RODTEP and ROSCTL schemes, respectively, keeping in view any post-notification issues.)

- To examine whether any further modifications are needed in the existing rates/caps for items covered under the RODTEP, ROSCTL schemes and the Drawback Schedule which have undergone change, either in description or Customs Tariff heading, consequent to the changes brought about in the Customs Tariff Schedule with effect from 01.05.2025.

The Committee held its first meeting on 9th October 2025 and has adopted a draft format for data submission by exporters.
