We wish to inform you that the Directorate General of Foreign Trade (DGFT) organized a virtual session on 04th November 2025 with various Testing and Inspection Agencies (TIAs) to introduce and demonstrate the “Bharat Aayat Niryat LabSetu” — a digital platform that brings all testing and inspection agencies across the country under a single window. The session included a presentation and live demonstration of the system’s key features and functionalities relevant to testing agencies.

In continuation of this initiative, DGFT has scheduled a virtual session for Exporters and Importers on 07th November 2025 (Friday) from 03:00 PM onwards.

This session will focus on:

- Introducing the LabSetu platform and its role in simplifying testing, inspection, and certification procedures for export and import consignments.
- Demonstrating how exporters/importers can use the portal to locate approved labs, request tests, track certifications, and access results digitally.
- Explaining the benefits of LabSetu, including faster turnaround times, reduced paperwork, and enhanced transparency.
- Addressing queries and providing step-by-step guidance for user onboarding.

All member exporters/importers are strongly encouraged to participate in the upcoming session to understand the platform and leverage its features for smoother trade facilitation.
