Subject: Central Government Notification: Cancellation of Specified BIS Notifications under Section 16, BIS Act 2016"

We wish to inform you that the Central Government, using the powers given under Section 16 of the Bureau of Indian Standards Act, 2016, and after consulting the Bureau of Indian Standards, has decided that certain previous notifications from the Ministry of Chemicals and Fertilizers are no longer in effect. This applies immediately, except for any actions that were already done under those notifications before this change.
