Sub: Final Election results for Election to the Committee of Administration (COA) as per Election Rules:- reg

We had vide our communication Ref: Plexh/Election/409 dated 06.08.2025 intimated the list of valid and invalid nominations received by the Council for the vacancies in the posts in the Committee of Administration. The last date for withdrawal of nomination was 5:00 p.m. on 11th August 2025.

The Committee deliberated upon the objections raised in the 4 cases and disposed off the objections with its observations as per the details given in an enclosed annexure.

Shri Mukesh Patani(Sr no.3 of the Annexure dt 12.8.25) had again raised objection against the invalid nomination vide his email dt 17.8.25 and same was again duly deliberated by the committee and the committee has re-iterated its decision. The decision has been conveyed to the applicant through a reasoned email dt 18.08.2025.

- 3) In respect of Regional Chairperson, South, 1 valid nomination was received and the said candidate is declared elected as unopposed.



North Easter/Hilly Region (2 posts).



1	Shivam Bansal	Plastalloy Pvt Ltd	Export House	<p>As per the objections of the candidate, he has mentioned that as per the Council's notification and Annexure, how a nominee knows that the person who is signing the form, his/her name was mentioned on IEC and RCMC or not.</p> <p>And, if the form has to be rejected due to the seconder's name not mentioned in IEC/RCMC, then at least name has to be mentioned of the person who is eligible to sign.</p> <p>This is really not acceptable from our side that the form is rejected due to this reason.</p>	<p>A)The clause no. 11 of the nomination form reads as under: Only authorize representative, whose name is mentioned in the RCMC/ IEC shall be eligible to contest proposed or seconded at the elections.</p> <p>B)In the Election Rules, 2025, on page 6, section (J), under the heading "Eligibility to Contest in Elections", it is clearly outlined that: Only the authorized representative, whose name is mentioned as such in the RCMC/IEC, while applying for membership with the Council shall be eligible to contest, propose or second at the Election. Hence the objections raised by the Invalid candidate is not justifiable.</p>
2	Anup Mahendra Gopalka	Umasree Texplast Pvt Ltd	MSME	The candidate has mentioned that he has attached the MSME certificate along with the application on 31st July, 2025	The latest MSME status could only be ascertained from the classification year 2025-26. Since the applicant has not submitted an updated MSME certificate clearly mentioning the MSME status for the current year, the committee is contrained to reject the nomination.
3	Mukesh Patani	Mukesh Patani	MSME	<p>As per information available on public domain, the certificate of MSME is valid indefinitely unless there is a significant change in business investment or turnover</p> <p>As Udhyaam Registration certificate does not require periodic renewal, it is valid for a lifetime. However, it is crucial to update your registration detail on the Udhyaam portal to reflect change in business turnover, investment or structure to maintain the accuracy of your classification and ensure continued access to Govt. benefits and schemes.</p> <p>This means that if there is no such material changes, there is no need to do any updating.</p>	The latest MSME status could only be ascertained from the classification year 2025-26.
