The country imports a wide range of products, including men's, women's, and kids' wear such as trousers, dresses, T-shirts, jerseys, jackets, pullovers, cardigans, shirts, suits, sportswear, shawls, caps, socks, gloves, belts, ties, infant wear, and other accessories. Among these, woven garments have higher demand compared to knitted garments, making Spain an important market for Indian exporters to target.
